## August Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 2.6 billion, compared to EUR 2.9 billion during the past 12-month period. The average number of trades per trading day was 565,966 compared to 594,797 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 273,422 compared to 282,500 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 2 091 billion, compared to EUR 1 706 billion in August 2023.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Iceland, Tallinn and Vilnius had 21 trading days and all other exchanges had 22 trading days.
