June Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.2 billion, compared to EUR 3.2 billion during the past 12-month period. The average number of trades per trading day was 615,628 compared to 668,254 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted to 310,384 compared to 283,122 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 829 billion, compared to EUR 2 071 billion in June 2024.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Helsinki and Vilnius had 20 trading days. All other exchanges had 19 trading days.
