## October Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.1 billion, compared to EUR 3.2 billion during the past 12-month period. The average number of trades per trading day was 610,846 compared to 667,990 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted to 272,704 compared to 288,355 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 924 billion, compared to EUR 1 946 billion in September 2024.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. All exchanges had 23 trading days.
