Oriola Corporation corrects the stock exchange release published on 23 September 2026 at 5:00 p.m. EEST regarding Mariatorp Oyj's flagging notification. The release did not include the date on which Mariatorp Oyj's ownership exceeded the 15 per cent threshold. The date (22 September 2026) has been included in the corrected stock exchange release below.

Oriola Corporation has received a disclosure from Mariatorp Oy under Chapter 9, Section 5 of the Securities Markets Act. According to the disclosure, Mariatorp Oy's ownership of Oriola Corporation's shares and voting rights increased on 22 September 2026 above 15 per cent.
