## May Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.1 billion, compared to EUR 3.1 billion during the past 12-month period. The average number of trades per trading day was 655,628 compared to 718,594 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 338,199 compared to 345,174 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 725 billion, compared to EUR 1 814 billion in May 2022.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Copenhagen and Riga had 19 trading days, Iceland 20 trading days and all other exchanges had 21 trading days.
