

Notification pursuant to Chapter 9, section 5 of the Securities Markets Act: Oy Högfors-Trading Ab's holding in Componenta has exceeded 15%

Componenta Corporation (Business ID 1635451-6) received on 15 August 2014 the following notification pursuant to Chapter 9, section 5 of the Securities Markets Act, according to which Oy Högfors-Trading Ab's holding of shares and voting rights of Componenta Corporation has exceeded 15%.

"NOTIFICATION PURSUANT TO CHAPTER 9, SECTION 5 OF THE SECURITIES MARKETS ACT

The holding of Oy Högfors-Trading Ab, where Heikki Lehtonen exercises control, in Componenta Corporation's shares and voting rights exceeds 15% as a result of the arrangement which if realized will lead into a situation where the flagging notice limit is exceeded.

In accordance with Chapter 9, section 5 of the Securities Markets Act, we announce to the Financial Supervisory Authority and Componenta Corporation the following:

2. Arrangement if realized shall lead into a situation where the shareholding and voting rights exceed the flagging notice limit of 15% according to Chapter 9, section 5 of the Securities Markets Act.
