October Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.0 billion, compared to EUR 3.7 billion during the past 12-month period. The average number of trades per trading day was 776,461 compared to 870,545 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 321,881 compared to 354,247 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 641 billion, compared to EUR 2 123 billion in October 2021.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Riga, Tallinn and Vilnius had 22 trading days and all other exchanges had 21 trading days.
