## June Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 2.9 billion, compared to EUR 3.1 billion during the past 12-month period. The average number of trades per trading day was 591,414 compared to 701,675 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 322,899 compared to 344,416 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 733 billion, compared to EUR 1 630 billion in June 2022.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Stockholm had 20 trading days, Iceland and Vilnius had 22 trading days and all other exchanges had 21 trading days.
