## August Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 2.8 billion, compared to EUR 3.9 billion during the past 12-month period. The average number of trades per trading day was 679,864 compared to 902,479 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 306,702 compared to 360,025 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 691 billion, compared to EUR 2 113 billion in August 2021.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Vilnius have 22 trading days. All other exchanges had 23 trading days.
