

1. About the Company

1.1. City Service Group

AB City Service (the Company thereinafter) is a public company registered in the Republic of Lithuania on 28 January, 1997.

The City Service group is the market leader in facility management and integrated utility services in the Baltic States. The Group operates in Lithuania, Latvia and Russian federation.

The Group specializes in managing the efficiency of buildings; maintenance and repair of engineering systems; management and renovation of energy resources; technical and energy audits of buildings; waste management and eco-business; maintenance and installation of lifts; maintenance and cleaning of territories.

The most important building segments administered by the City Service group are residential apartment buildings; commercial buildings; public buildings; industrial buildings. The total area of buildings under the management of the Group is 18.6 million sq. m. at present.










1.2. Structure of the Group

1.3. Key events

January

In January commercial facility management and maintenance activities were transferred to the subsidiary of the Company, UAB City Service LT.

February

On 15 February, an increase in the authorised capital of UAB City Service LT was registered with the Register of Legal Entities. The Company acquired all new shares issued by UAB City Service LT and holds 100% of the shares.

March

In March subsidiaries which manage residential facilities in Lithuania and perform other activities related with the residential facility management were transferred to direct control of UAB City Service LT.

February – May

In February – May, a common trademark group of companies controlled by the Company was formed. The names of the companies operating in Vilnius, Kaunas, Klaipeda, Siauliai, Radviliskis and Šilutė were changed.

June

The Company has won the tender announced by the Vilnius city municipality (Lithuania) to install 20 new children playgrounds in Vilnius. The Company shall maintain the playgrounds for another 3 years.

July


Lithuanian division of City Service group enhanced its management team. In UAB City Service LT, which combines all types of activities carried out in Lithuania, a separate Board of the Company was formed, with Jonas Janukėnas as the Chairman. UAB City Service LT is now headed by Vytautas Turonis, General Director; he was previously Executive Director of AB City Service in Lithuania. Edvinas Paulauskas, Commercial Director of AB City Service, became the Executive Director of UAB City Service LT.

On 1 July, SIA Riga City Service, a Latvia-based company, started maintaining a chain of Lukoil gas stations, second largest in Latvia.


On 9 of July Company's name UAB City Service LT was changed to UAB Mano Būstas LT.

2. Activities in Lithuania



Apartment building maintenance. As the Company still focuses on the maintenance of apartment buildings in the Lithuanian market, further steps were taken to enhance quality of services and maintenance works.

In course of implementation of operation optimisation technique Lean 6 Sigma, a new motivation system was launched across Lithuania. The system was first tested at one of the Group's subsidiaries; as a result, additional sales in the company increased twice.

While implementing the "5-step heat saving program" and seeking to cut heat loss in apartment buildings, heat saving measures shall be further implemented. "5-step heat saving program" connects 788 buildings across Lithuania. During

summer, preparations continued for the next heating season. The average heat usage indices in the houses that participated in the program improved by 17 per cent during 2011 – 2012 as compared to 2009 – 2010.

The Company, seeking to improve communication with clients, raise awareness and thus the service quality, continued forming of common trademark group. On 9 July, Lithuanian branch of the Company changed its name from City Service LT to Mano būstas LT. Mano būstas (direct translation – "My Home") is now main trademark of the Company in Lithuania.

In the first half of 2012, a project "Let's get to know each other" was carried out across Lithuania. Employees of the Company visited yards of apartment buildings on weekdays, in the morning and in the evening, and distributed a leaflet on the Company, inviting to introduce oneself and discuss any relevant issues. This was intended to enhance relationship with clients and raise awareness of the Company.

Antakalnio būstas, part of the Group, was the first one in Vilnius to start apartment building renovation projects under JESSICA program. The program now includes renovation of one apartment building, with plans to start renovation works on another 5 apartment buildings by the end of the year.

In the early year, clients at Karoliniškių būstas, a subsidiary, were given access to a new self-service portal. It is very easy and convenient to manage administration-related matters in the electronic environment, i.e. to pay for utility services, review messages on payments, find detailed information on works planned for the apartment building and in the district and to contact the building manager servicing the house directly. This year it is planned that the majority of residents in buildings administered by the Group will have access to the self-service portal.

In the second half of 2012, the Company shall seek to further enhance quality of services provided. As the heating season approaches, focus shall be placed on works reducing heat consumption and heating bills.

Maintenance and renovation of elevators. During first six months, the Company expanded its operation in this segment, as subsidiary Baltijos liftai increased number of lifts maintained from 500 to 800.

The Company has also enhanced segment of services related to lift modernisation, with total of 18 lifts renovated in the apartment buildings. While carrying out lift modernisation projects, the Company expects to renew lifts, reaching the marginal operation period in the major Lithuanian cities, in line with the directives and standards of the European Union.



The Company continued implementation of operation optimisation technique Lean 6 Sigma. This included a detailed review of product characteristics at Šiaulių liftas and a cut of 15% in the production prime cost.

In the second half of the year, the Company expects to continue optimisation projects; furthermore, by standardising the lift for the disabled at Šiaulių liftas, the Company expects to cut the prime costs of the product by 30%, and the production time by 30%.

Baltijos liftai further intends to enhance escalator maintenance services and to increase number of clients in the commercial segment. In the short term, the company also intends to continue enhancement of services related to modernisation and renovation of lifts.

Commercial, industrial and public facility management. The Company has won the tender announced by the Vilnius city municipality to install 20 new children playgrounds in Vilnius. The playgrounds shall be installed by Economus, part of the Group, in cooperation with its partners under partnership agreement. The Company shall maintain the playgrounds for another 3 years after the installation.

In the first half-year, the Company further increased number of clients.

The Company started providing services to the Ministry of National Defence of the Republic of Lithuania on maintenance of electricity, water supply, cooling, and heating systems. The services cover 70 objects in Alytus, Marijampolė, and Klaipėda regions. The area under maintenance exceeds 56,000 square meters.

An agreement was signed with Vilnius Gediminas Technical University for management of student dormitories. Total area under management is approximately 30,000 square meters.

Also an agreement on management of household in object and maintenance services was signed with the Embassy of Sweden.

In cooperation with LESTO, a project, Electrician on demand, continued. Over the first half of 2012, volume of services provided per month expanded almost twice.

Waste management. In the first half of 2012, Ecoservice, a subsidiary of the Group, expanded its activities to Pagégiai municipality.

Ecoservice also expanded territory of waste sorting service, i.e. an opportunity to sort waste was provided to residents in Pakruoiis town.

As waste sorting and recycling project expanded further, a campaign Eko courage was carried out across Lithuania. The campaign involved over 460 education institutions. A total of 278 tons of waste paper and tetra packs, 35 tons of electronics waste and 0.5 ton of galvanic cells was collected and taken for recycling.

Maintenance and cleaning of territories. The Company expanded activities in the field of cleaning and maintenance of territories, thereby adding to the competitive advantage of the Company.

In the course of implementing optimisation technique, Lean 6 Sigma, a mechanisation of manual labour was carried; a lawn-mowing robot and other equipment for maintenance and cleaning of territories were acquired. It allowed improvement in services quality and to dispense with temporary employees recruited for summer. As the number of positions was reduced, there was an opportunity to raise salary to the full-time professionals employed in the Company; criteria applicable to the quality of works were improved and steps were taken to make the employees more loyal.



3. Activities in foreign markets

3.1. Russia



As administration of apartment buildings remains the priority activity of the Group in Russia, territory maintenance work continued in Sankt-Petersburg and Stavropol, based on maintenance agreements with city district administrations. The Company has also actively studied and monitored the market and considered opportunities to acquire private and State companies, administering apartment buildings in the Central, Western and Southern regions of the Russian Federation.

In order to make the use of internal resources more efficient, cut costs and perfect process management, Group's companies in Russia started implementing experience on Lean 6 Sigma operation optimisation, gained in Lithuania. Main objectives of optimisation in Russia are to install a management system for the flow of estimates, optimize data transmission and resource-purchase and storage processes required for the realization of technical projects; we shall also encourage employees to share their ideas in this field.

Deliberation on draft legislation in the Duma of the Russian Federation concerning new clause applicable to companies dealing with administration of apartment buildings was postponed to the autumn session 2012. The same clause can compel the companies dealing with administration of apartment buildings to join associations, setting certain operational standards. Membership in the profile-based associations will give rise to financial obligations, which shall be insignificant to larger companies, such as City Service group; however, they can eliminate from the market small companies with few buildings under their management.

3.2. Latvia



Riga City Service, a Latvia-based subsidiary of the Group, enhanced the segment of managed public in the first half of 2012.

4 new agreements on building maintenance were signed and 19 new objects are now maintained.

The Company continued expanding number of clients in the field of management of commercial premises. The Company has won a tender and started maintenance of Lukoil chain of gas stations, second largest in Latvia. Riga City Service shall ensure maintenance of all systems and facilities in buildings, ensure operation of facilities of electricity, water

and sewage, ventilation and air conditioning, cooling, as well as perform minor repairs

In total, Riga City Service shall maintain a total of 60 Lukoil gas stations across Latvia, with the total area maintained of 18,000 square meters.

The total area of the buildings now managed by Riga City Service totals 422,000 square metres, the territory managed totals 2.8 million square metres.



4. Employees

During the first six months of 2012, The Company's efforts to optimise operation were awarded. The Company's project "Training of universal technicians (housekeepers)" was successful in the competition of best practice in the field of personnel management. The competition was run by the Association of Personnel Training Professionals. In the final, the training project of City Service was declared better than those of other leaders in the competition, i.e. Blue Bridge company and SEB bank.

The purpose of the mentioned project is to train universal technicians (housekeepers), to carry out various works. Given these trainings, company technicians become universal employees, who maintain a smaller number of buildings; however, they are able to deal with most issues arising there. The project was also launched in Kaunas in the first half of 2012.



A training project of building maintenance managers was completed in the first half of 2012, embracing whole Lithuania. The training involved 87 managers in the sector of apartment buildings and 39 managers of commercial segment. The program was composed, taking into account the need for development of specific competencies, upon prior assessment of competencies of managers. The project is intended to ensure the competency of Company managers and thus enhance quality of services and servicing.

The Company has also carried out training for manager of its subsidiary companies. The training included enhancement of leadership and management competencies, general competencies; attention was also given to expertise directly related to the work.

Darius Leščinskas



At present, the main task of the General Manager is to head the holding and take charge of planning and coordination of important development projects in Russia, Poland, as well as other markets in Eastern and Western Europe.

Since 2012, Mr Janukėnas is also the Finance and Administration Manager and the Chairman of the Board of at Mano būstas LT UAB. He holds a Master's degree in Business Administration. Prior to coming to work at the Company, he worked as the Senior Auditor and Risk Management Consultant at the Vilnius division of Andersen (1998 – 2001) and the Financial Manager of UAB Litesko (2001 – 2007).

The Finance and Administrative Manager Jonas Janukėnas is responsible for the management of financial resources of the Group and for supervision of the administrative staff, IT projects implementation and Lean 6 Sigma project.

He holds a Bachelor's degree in International Business. Previously he worked as the Marketing Manager of UAB Specialus Autotransportas (2003 – 2004). He started to work in the Company as the Market Development Department Manager (2004 – 2008).

Executive Manager for Lithuania is responsible for the Group's activities in Lithuania.



Tomas Augutavičius

He started working in the Company as Head of Kaunas Department (2006 - 2009). Edvinas Paulauskas (born 1976) is the Executive Manager at Mano būstas LT UAB and Commercial Director at City Service AB. He holds a Bachelor's degree in Environment Engineering. Edvinas Paulauskas started working in the Company in 2005 and worked as the Project Manager (2005 - 2006) and Executive Manager (2006 - 2008).

Edvinas Paulauskas is responsible for the facility management projects of commercial and public establishments and for lift maintenance and renovation.

6. Data about agreements with intermediaries of public trading in securities

On 27 March 2007 the Company and Swedbank AB concluded the contract on transfer of issuer's securities accounting which is valid today.

On 27 November 2007 the Company signed a liquidity provider agreement with UAB FMĮ Orion Securities, which started a liquidity provider activity from 3 December 2007. The contract is still valid.

7. Data about issuer's securities traded on regulated markets

On 30 June, 2012 all 31,610,000 ordinary registered shares of the Company were included into Official List of NASDAQ OMX Vilnius Stock Exchange, nominal value of one share – LTL 1 each. ISIN Code of the shares is LT0000127375, trading code of the shares on NASDAQ OMX Vilnius Stock Exchange – CTS1L.

Trading of the shares on Vilnius Stock Exchange started on 8 June 2007.

8. Structure of the Company Authorised capital and Shares

During period from 1 January 2012 till 30 June 2012 authorised share capital of the Company was LTL 31,610,000. The authorised share capital of the Company was divided into 31,610 thousand ordinary registered shares with the nominal value of 1 LTL each.

There are no any restrictions of share rights or special control rights for the shareholders settled in the Articles of Association of the Company.

No shares of the Company are held by itself or its subsidiaries. No convertible securities, exchangeable securities or securities with changeable value or with the warrants or any other securities are issued by the Company.

There are no outstanding acquisition rights or undertakings to increase share capital.

All shares of the Company are paid up. All shares of the Company give equal rights to the shareholders of the Company. The Company has not issued any other class of shares than ordinary shares mentioned above.

The shareholders shall have no other obligations to the Company except for the obligation to pay up, in the prescribed manner, all the shares subscribed for at their issue price.
