

**January 2, 2026**
**December Statistics report from the Nasdaq Nordic and Baltic markets**

The value of average daily share trading amounted to EUR 3.0 billion, compared to EUR 3.2 billion during the past 12-month period. The average number of trades per trading day was 528,830 compared to 654,589 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted to 352,468 compared to 291,630 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 2 003 billion, compared to EUR 1 859 billion in December 2024.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. All exchanges had 19 trading days.
