March Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 4.7 billion, compared to EUR 4.0 billion during the past 12-month period. The average number of trades per trading day was 1 054,925 compared to 926,388 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 517,793 compared to 348,732 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 924 billion, compared to EUR 1 816 billion in March 2021.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK and other in EUR) and average per trading day. Vilnius had 22 trading days and all other exchanges had 23 trading days.
