Royal Bank of Canada issued EUR2,250,000,000 3.375 per cent. Covered Bonds due September 15, 2031 (the **"2031 Covered Bonds"**) and EUR750,000,000 3.750 per cent. Covered Bonds due September 15, 2036 (the **"2036 Covered Bonds"** and, together with the 2031 Covered Bonds, the **"Covered Bonds"**) on September 15, 2026, pursuant to the €75,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the **"Programme"**).

The following documents constitute the final terms dated September 11, 2026, in respect of the 2031 Covered Bonds and the final terms dated September 11, 2026, in respect of the 2036 Covered Bonds (collectively, the **"Final Terms"**) relating to the issue of the Covered Bonds for purpose of PRM 2.3 and must be read in conjunction with the Prospectus dated July 9, 2026, as supplemented by the 1st Supplementary Base Prospectus dated August 28, 2026, relating to the Programme (together, the **"Prospectus"**). Full information on Royal Bank of Canada and the offer of the Covered Bonds is only available on the basis of the combination of the Final Terms and the Prospectus.
