November Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.0 billion, compared to EUR 3.0 billion during the past 12-month period. The average number of trades per trading day was 632,843 compared to 605,942 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 280,784 compared to 280,013 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 930 billion, compared to EUR 1 769 billion in November 2023.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Riga and Vilnius had 20 trading days, and all other exchanges had 21 trading days.
