hereinafter the Depositary, the Company and the Management Company being jointly referred to as 'the **Parties**' and each individually as 'the Party'.

WHEREAS the Parties seek to amend Clause 4.3.1 of Depositary Services Agreement No 2016-11 of 10 November 2016 (as amended and restated on 29 December 2017, as subsequently amended, hereinafter referred to as 'the **Agreement**'),

have entered into this Amendment No. 5 to the Agreement (hereinafter 'the Amendment'), whereby they have agreed:

- To amend Clause 4.3.1 of the Agreement to read as follows:
 '4.3.1. The Depositary Service Fee shall be percent per annum, calculated on the last reconciled value of the Company's net assets at the frequency provided for in the Articles of Association of the Company, but not less frequently than every quarter;'.
- 2. The Amendment shall enter into force from the date of signature hereof, but in any event not earlier than the Amendment is approved by the General Meeting of Shareholders of the Company.
- 3. From the date of entry into force hereof, the Amendment shall become an integral part of the Agreement and shall be subject to all the terms and conditions provided for therein.
- 4. This Amendment is executed in three (3) counterparts of equal legal force or is e-signed. The Company undertakes to submit one copy of the Amendment to the Bank of Lithuania.
