May Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.5 billion, compared to EUR 3.2 billion during the past 12-month period. The average number of trades per trading day was 695,503 compared to 665,770 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted to 293,149 compared to 283,240 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 854 billion, compared to EUR 2 062 billion in May 2024.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Riga had 19 trading days, Copenhagen 21 trading days and all other exchanges had 20 trading days.
