December Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.1 billion, compared to EUR 2.9 billion during the past 12-month period. The average number of trades per trading day was 602,736 compared to 618,976 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 289,272 compared to 286,875 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 898 billion, compared to EUR 1 712 billion in December 2022.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Helsinki had 18 trading days and all other exchanges had 19 trading days.
