December Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 2.8 billion, compared to EUR 3.6 billion during the past 12-month period. The average number of trades per trading day was 640,287 compared to 836,235 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 318,589 compared to 352,254 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 712 billion, compared to EUR 2 202 billion in December 2021.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Helsinki had 20 trading days and all other exchanges had 21 trading days.
