## April Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.2 billion, compared to EUR 3.2 billion during the past 12-month period. The average number of trades per trading day was 687,469 compared to 740,558 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 410,848 compared to 343,665 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 799 billion, compared to EUR 1 872 billion in April 2022.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Iceland had 16 trading days, Copenhagen 17 trading days and all other exchanges had 18 trading days.
