Notice of written procedure for bonds issued by Gefion Group Holdco ApS

To the holders of the Secured Floating Rate Bonds 2022/2025 with ISIN: EUR BONDS: SE0018767899 and SEK BONDS: SE0018767881 (the "Bonds") issued by Gefion Group Holdco ApS (CVR-nr. 39312794) (the "Issuer"), under terms and conditions originally dated 9 November 2022 and as amended and restated through a written procedure concluded on 18 December 2023.

Capitalised terms not otherwise defined in this notice shall have the meaning given to them in the terms and conditions relating to the Bonds (the "Terms and Conditions").

This notice has been sent by CSC (Sweden) AB (previously under company name Intertrust (Sweden) AB) (the "Agent") to direct registered owners (Sw. *direktregistrerad ägare*) and registered authorised nominees (Sw. *förvaltare*) of the Bonds recorded as of 10 September 2026 in the debt ledger produced by Euroclear Sweden AB (the "CSD"). If you are an authorised nominee under the Swedish Financial Instruments Accounts Act or if you otherwise are holding Bonds on behalf of someone else on a Securities Account, please forward this notice to the holder you represent as soon as possible. See "Voting rights" in Section D (*Decision procedure*) for further information.

On behalf of and as requested by the Issuer, the Agent, acting in its capacity as Agent for the Bondholders under the Terms and Conditions, hereby initiates a written procedure (the "**Written Procedure**"), whereby the Bondholders can approve or reject a proposal from the Issuer regarding certain amendments to and a waiver under the Terms and Conditions. The proposal by the Issuer and the background thereto is described in Section A (*Background and Proposal*).

NO DUE DILIGENCE CARRIED OUT IN CONNECTION WITH THIS WRITTEN PROCEDURE

Please note that no documentary due diligence whatsoever (legal, financial, tax, environment or otherwise) has been carried out by the Agent, the solicitation agent for the Written Procedure, any of their advisors or any other person for the purposes of the Written Procedure or with respect to the Issuer or its assets, other than some specific confirmatory questions directed to and answered by the management of the Issuer.

It should be noted that the risk factors appended to the Investor Presentation (that can be found on <https://blog.cscglobal.com/our-services/capital-markets-services/bond-news/>) have not been produced specifically for this Written Procedure but merely been updated based on the specific questions directed to the management of the Issuer referred to above.

Bondholders are recommended to seek their own professional advice in order to independently evaluate whether the Proposal (and its effects) is acceptable or not. Neither the Agent, nor any of its advisors has carried out any due diligence in connection with the Proposal and no party can guarantee any satisfactory outcome of the Proposal set out herein.

PARTICIPATION IN THE WRITTEN PROCEDURE

Bondholders may participate in the Written Procedure by completing and sending the voting form attached below to the Agent. The Agent must **receive the voting form no later than by 12.00 (CEST) on 7 October 2026** by mail, via courier or e-mail to the addresses indicated below. Votes received thereafter will be disregarded. Please note that the Written Procedure may expire early if the requisite majority consents of the total Adjusted Nominal Amount have been received before **7 October 2026**.

To be eligible to participate in the Written Procedure a person must fulfil the formal criteria for being a Bondholder on 17 September 2026 (the "Record Date"). This means that the person must be registered on a Securities Account with the CSD as a direct registered owner (*Sw. direktregistrerad ägare*) or authorised nominee (*Sw. förvaltare*) with respect to one or several Bonds.

If you have an interest in a Bond but are not registered as a direct registered owner or authorised nominee on a Securities Account, you need to obtain a power of attorney or other proof of authorisation from the person who fulfils the formal criteria for being a Bondholder on the Record Date, to be able to participate. An alternative may be to ask the person that is registered as a Bondholder and holds the Bonds on your behalf to vote in its own name as instructed by you. A. Background and Proposal

1. Background

The Issuer is a private limited liability company incorporated in Denmark, with CVR-no. 39312794, and part of Gefion Group A/S ("**Gefion**" or, together with its subsidiaries, the "**Group**"). Since its foundation in 2013, the Group has converted old buildings and constructed new developments into several milestone projects within the Copenhagen area, including approximately 2,700 residential and commercial units, spanning over 30 projects (please see the Investor Presentation for details). To finance the acquisition and development of the property portfolio, in November 2022, the Issuer issued the Initial Bonds and has thereafter carried out one Subsequent Bond Issue.

In November 2023, the Issuer initiated a written procedure to amend certain terms of the Terms and Conditions, which was concluded on 18 December 2023 (the "**First Written Procedure**"). Due to changed market conditions regarding increased interest rates and reduced investor appetite/pricing, two specific project related events affected the Issuer's short term liquidity position adversely. The current total outstanding amount under the Bonds is SEK 292,240,000 and EUR 24,114,000 with a current Final Maturity Date falling on 11 November 2027.

The First Written Procedure included a revised business and liquidity plan and showed that the Issuer should be in a position to fully repay the Bonds with divestments of the projects Holbæk (several phases), Havdrup (phase 1), Køge Nord, Billund Hovedgade, Nexø Havn, and Hornbæk Eng while major value drivers such as Hillerød Posthus would remain for the company to develop. The main risk, besides market risks on sales and construction prices, were delays of municipal decisions.

Gefion has kept its plan to develop the projects; however, it has been affected negatively by business risks associated with land and real estate development. The first (of several) local plan of the Holbæk-project was supposed to be approved at the end of 2024. The first local plan has now been approved, and the majority of the first phase will be divested, expected to occur in Q3 2026. However, as the business case has been with Holbæk since the project was initiated, the proceeds from the first divestment will be reinvested in the project and not yield any significant liquidity to the Issuer.

As these larger projects have been delayed significantly, Gefion has focused on preserving the liquidity of the Group, which Gefion has reported in its quarterly reports on an ongoing basis. To follow such a liquidity plan, several project divestments have been done, including Hornbæk Eng and Hillerød Posthus. The divestments of these projects have had a positive impact on the Group's result and short-term liquidity, although a smaller profit than budgeted has been realised. These project divestments show good examples of how Gefion continues to build values that is not shown in the balance of the Group. As the divestments were executed through the sale of building rights rather than completion of the projects, the divestments generated lower profits compared to internal management evaluations, while removing significant risk and providing short-term liquidity to the Group.

We at Gefion remain fully committed to returning the capital and return to our investors and, although not directly shown in our financial figures, see significant values being created in our portfolio. We need to continue to invest in our projects to create divisible values used for redeeming the Bonds and are thus proposing the request set out in the Proposal. The Proposal has been carefully structured to allow us at Gefion to continue with our project investments, while we commit to use any excess cash to the Bondholders.

The Proposal has been discussed with the two (to the Issuer known) largest Bondholders, whom have indicated that they are in favour of the Proposal.

Consequences of not accepting the Proposal

The consequence of not accepting the Proposal could, in the short term, lead to the Issuer not being able to serve its interest payments (settled by cash) which will increase from the current 2 per cent. *per annum*, paid quarterly in arrears, to STIBOR90/EURIBOR90 + 10.00 per cent. *per annum* starting 12 November 2026. The Issuer currently has, and forecasts, liquidity to serve its ongoing operations and development expenses but not a fully resumed cash interest payment.

Furthermore, the Issuer and the Guarantor have negative consolidated equity, and their projects, to the majority, consist of conditional purchase agreements. Although the management of Gefion estimates that the values of the project portfolio surpass the value of the Group liabilities, such valuation estimates are done on a going concern basis, and it is a significant risk that the values cannot be achieved in a forced or stressed divestment process. In the Issuer's assessment, not accepting the Proposal would lead to the Issuer not realising the values in the portfolio and could lead to a significant loss for the Bondholders.

The short-, and long-term effects of not accepting the Proposal are why the Issuer considers it to be in the Bondholders' interest to accept the Proposal. The Bondholders should note that the Proposal, if approved, is also not without risk. Bondholders are encouraged to review the risk factors appended to the Investor Presentation when evaluating both the potential consequences of not accepting the Proposal and the risks associated with the Proposal itself.

2. Proposal and request for waiver

The amendments proposed by the Issuer to be made to the Terms and Conditions are set forth in full in Schedule 1 (*Proposed Amended and Restated Terms and Conditions*), where blue and underlined text indicates additions (i.e. [additions](#)) whereas red and crossed-out text indicates deletions (i.e. ~~deletions~~). A summary of the proposed amendments to and waiver under the Terms and Conditions are also set forth below in this Paragraph 2.

Waiver of the Incurrence Test required to issue Subsequent Bonds in connection with the Proposal

The Issuer is requesting the Bondholders' approval to waive the requirement under Clause 2(e) of the Terms and Conditions stating that the Incurrence Test must be met in order for the Issuer to carry out a one-off issue of Subsequent Bonds in connection with the Proposal. Such waiver shall only extend to Subsequent Bonds issued in SEK and/or EUR for the purpose of settling advisory fees incurred by the Issuer in connection with the Written Procedure.

The maximum amount of Subsequent Bonds issued pursuant to this section shall not exceed an aggregate nominal amount equal to the EUR and SEK equivalent of approximately DKK 10,000,000. Any Subsequent Bonds issued pursuant to this section (i) must be issued by the Issuer no later than two (2) weeks from the date of registration of the amended Terms and Conditions with the CSD and (ii) may only be issued by the Issuer on one (1) occasion. Any Subsequent Bonds so issued shall be regarded as Permitted Debt. For the avoidance of doubt, the requested waiver relates solely to the Incurrence Test under Clause 2(e) and the classification as Permitted Debt in respect of this one-off issue of Subsequent Bonds and does not otherwise affect the maximum total nominal amount of the Bonds permitted under the Terms and Conditions, within which cap any such Subsequent Bonds must be issued.

Extended Final Maturity Date

The Final Maturity Date was originally 11 November 2025, subject to two extension options of twelve (12) months each to 11 November 2026 and 11 November 2027, respectively. It is proposed to extend the Final Maturity Date to 11 November 2028 and to introduce one new extension option of twelve (12) months, extending the Final Maturity Date to 11 November 2029 if utilised by the Issuer.

Mandatory Partial Redemption of the Bonds

It is proposed that (i) the net proceeds from divestment of projects, and (ii) money distributed upwards – net of payments made in order to repay existing debt within such project's holding structure – by a Group Company following it having incurred an Acquisition Facility or a Construction Facility (or it having refinanced any such facility), shall, in each case (i)-(ii), be applied towards partial redemption of the Bonds on the terms as further specified in the proposed amended Terms and Conditions (including, *inter alia*, taking into account the cash position of the Group when determining what part of the net proceeds, in case of a divestment, or distributed money, in case of a distribution following a financing or refinancing, shall be applied for such partial redemption, whereas the Group shall be permitted to retain DKK 50,000,000 in non-restricted available liquidity for the purpose of funding twelve (12) months operating liquidity and early development expenses). The Issuer shall be responsible to make such calculations in accordance with the principles set forth in the proposed amended Terms and Conditions (and the Agent shall not be required to verify such calculations). Any redemption amount that falls below the equivalent of DKK 1,000,000 shall be paid into the Blocked Account until a total amount of DKK 1,000,000 is met (the "**Minimum Redemption Amount**"), whereafter the mandatory partial redemption of the Bonds shall be made. Once the Minimum Redemption Amount has been reached or exceeded, the Issuer shall request the release of the relevant funds from the Blocked Account and provide the Agent with a certificate (the content of which the Agent shall not be responsible to verify) confirming that the Minimum Redemption Amount will be used to partially redeem the Bonds. Until the Minimum Redemption Amount has been met, the Issuer may also, by providing the Agent with a certificate (the content of which the Agent shall not be responsible to verify), request that net proceeds deposited on the Blocked Account following a divestment or distribution (as outlined above) be released from the Blocked Account, in an amount of not less than DKK 100,000, for the purpose of reinvesting such amount in the Issuer's existing projects. The Agent may, in its sole discretion, consent to the release of funds from the Blocked Account upon receipt of a certificate as described above.

Interest Payments and Redemption Premium

Pursuant to the First Written Procedure, it was proposed that the current interest payment structure be changed so that (i) two (2) per cent. *per annum* on the Bonds was paid in cash on each Interest Payment Date (the "**Cash Interest**") and (ii) the remaining interest (relevant IBOR *plus* Margin *minus* two (2) per cent.) was compounded on each Interest Payment Date (and thereafter carry Interest) (the "**PIK Interest**") and that payment of it was deferred to the relevant Final Maturity Date.

It is proposed to amend the Bonds from floating rate to fixed rate, converting the existing Cash Interest to a two (2) per cent. *per annum* fixed rate. To compensate the Bondholders for the remainder of the current interest structure (i.e. the PIK Interest), the Issuer proposes that:

- the PIK Interest accrued up until the Interest Effective Date (as defined below) will be converted into one (1) deferred interest payment, which will be a fixed amount, payable in SEK and in EUR, respectively, which will be paid by the Issuer upon redemption (partially or in full) of the Bonds and such amount will be increased upon the issuance of any Subsequent Bonds as further described below (the "**Deferred Interest**"); and
- the future PIK Interest that would accrue from (but excluding) the Interest Effective Date (i.e. that will be deleted from the proposed amended Terms and Conditions) will be compensated, together with the Consent Fee (as defined and described below), by amending the Redemption Premium as follows. The payable Redemption Premium shall be an amount calculated by multiplying the applicable percentage specified below with the aggregate of the Nominal Amount and the Deferred Interest. Consequently, upon redemption (partially or in full), the Bonds shall be redeemable at a price equal to (i) 100 per cent. of the Nominal Amount or, in connection with a partial redemption, the repaid percentage of the Nominal Amount, *plus* (ii) 100 per cent. of the Deferred Interest or, in connection with a partial redemption, the repaid percentage of the Deferred Interest, *plus* (iii) an amount equal to the applicable Redemption Premium, which shall be:

- if the Bonds are redeemed (partially or in full) on or before 11 November 2026, a redemption premium of 5.53 per cent. for SEK Bonds and a redemption premium of 5.63 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 November 2026 but on or before 11 February 2027, a redemption premium of 8.13 per cent. for SEK Bonds and a redemption premium of 8.34 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 February 2027 but on or before 11 May 2027, a redemption premium of 10.70 per cent. for SEK Bonds and a redemption premium of 11.02 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 May 2027 but on or before 11 August 2027, a redemption premium of 13.42 per cent. for SEK Bonds and a redemption premium of 13.87 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 August 2027 but on or before 11 November 2027, a redemption premium of 16.22 per cent. for SEK Bonds and a redemption premium of 16.79 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 November 2027 but on or before 11 February 2028, a redemption premium of 19.44 per cent. for SEK Bonds and a redemption premium of 19.95 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 February 2028 but on or before 11 May 2028, a redemption premium of 22.38 per cent. for SEK Bonds and a redemption premium of 23.00 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 May 2028 but on or before 11 August 2028, a redemption premium of 25.46 per cent. for SEK Bonds and a redemption premium of 26.19 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 August 2028 but on or before 11 November 2028, a redemption premium of 28.62 per cent. for SEK Bonds and a redemption premium of 29.46 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 November 2028 but on or before 11 February 2029, a redemption premium of 32.14 per cent. for SEK Bonds and a redemption premium of 32.89 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 February 2029 but on or before 11 May 2029, a redemption premium of 35.39 per cent. for SEK Bonds and a redemption premium of 36.24 per cent. for EUR Bonds;
- if the Bonds are redeemed (partially or in full) after 11 May 2029 but on or before 11 August 2029, a redemption premium of 38.84 per cent. for SEK Bonds and a redemption premium of 39.79 per cent. for EUR Bonds; and
- if the Bonds are redeemed (partially or in full) after 11 August 2029 but on or before 11 November 2029, a redemption premium of 42.38 per cent. for SEK Bonds and a redemption premium of 43.43 per cent. for EUR Bonds.

The redemption premiums stated above have been calculated as one (1), two (2), and three (3) year SEK swap rates and EUR swap rates (as applicable) retrieved from Bloomberg on 11 August 2026 *plus* eight (8)

per cent., accrued and capitalised quarterly, *plus* one point five (1.5) per cent. (equal to the Consent Fee (as defined below)).

In accordance with the proposed amended Terms and Conditions, upon any redemption of the Bonds (whether in full or in part) the Issuer shall, in addition to the amounts set out above, pay the applicable Accrued But Unpaid Interest. For the avoidance of doubt, the applicable Redemption Premium shall be calculated on the basis of 100 per cent. of the Nominal Amount and the Deferred Interest or, in connection with a partial redemption, the repaid percentage of the Nominal Amount and the Deferred Interest.

Any Subsequent Bonds issued after the Interest Effective Date will be subject to the same ISIN as the Initial Bonds and Subsequent Bonds issued before the Interest Effective Date, which means that the Issuer will be unable to determine when a certain Bond was issued. Due to such administrative reasons, the Issuer therefore proposes that any Subsequent Bonds issued after the Interest Effective Date shall be entitled to receive Deferred Interest in the same proportion as the Bonds outstanding on the Interest Effective Date. Upon issuance of any Subsequent Bonds, the Deferred Interest amount payable by the Issuer upon a redemption of the Bonds will thus be increased correspondingly.

Right to request the release of certain Transaction Security

As further specified in the proposed amended Terms and Conditions (Clause 13.5(b)), the Issuer is requesting the Bondholders' approval to dispose of the shares in, or discontinue, the Group Companies subject to Transaction Security listed below, in each case subject to the relevant project of such Group Company having been divested. Consequently, the Issuer is requesting the Bondholders to, following the Issuer's written request to the Agent in accordance with the terms of the proposed amended Terms and Conditions, release the below Transaction Security upon the date of completion of such divestment or dissolution:

- Danish law governed share pledge over the shares in Rødovre Port Holding ApS, CVR. no. 37043060;
- Danish law governed share pledge over the shares in HKP 1A Holding ApS, CVR. no. 39348942;
- Danish law governed share pledge over the shares in Kanalgaden 3 Holding 1 ApS, CVR. no. 39357615; and
- Danish law governed share pledge over the shares in GG Engvej 155 Holding 1 ApS, CVR. no. 39348896.

The Issuer shall, by written notice to the Agent (the content of which the Agent shall not be required to verify), confirm that the conditions for the release of Transaction Security set out above have or will be met and request the release of such Transaction Security at a specified date. For the avoidance of doubt, the application of any Divestment Net Proceeds and any amounts standing to the credit of the Blocked Account shall be governed by Clauses 9.5 and 9.6 of the proposed amended Terms and Conditions, as applicable. The release of the abovementioned Transaction Security would reduce the total pool of Transaction Security available to the Bondholders in an enforcement scenario. However, since the release is conditional upon the relevant project having been divested and the net proceeds from such divestment being applied towards mandatory partial redemption of the Bonds (as described under the section "*Mandatory Partial Redemption of the Bonds*" above) or be put aside on the Blocked Account until the Minimum Redemption Amount has been met or reinvested in the Issuer's projects, the economic value of the divested projects will flow to the Bondholders in the form of (i) partial redemption rather than remaining as security over entities that no longer hold any underlying project assets or (ii) remain at the Blocked Account (and thus be subject to Transaction Security). Once the Minimum Redemption Amount has been met, the Issuer shall request release of the relevant amount from the Blocked Account for the purpose of executing a partial redemption of the Bonds, unless such funds have already been released for and reinvested in the Issuer's projects. The Agent shall be entitled (in its sole discretion) to consent to

such release from the Blocked Account in its capacity as Security Agent acting on behalf of the Bondholders.

Other amendments

In addition to the above, the Issuer is proposing to make the following amendments to the Terms and Conditions:

- the Issuer shall no later than six (6) months after the end of each financial year, publish on its website the annual audited consolidated financial statements of the Group (instead of five months after the end of each financial year);
- all future projects shall be owned (directly or indirectly) by Gefion Group Holdco III A/S (instead of the direct or indirect Subsidiaries of the Issuer);
- amendment of the definition of Subsidiary by way of decreasing the threshold from fifty (50) per cent. of the total number of votes held by the owners to twenty (20) per cent.;
- insertion of a reporting and disclosure obligation for the Issuer as required pursuant to the rules, regulations and guidelines applicable from time to time to issuers with debt securities admitted to trading on Nasdaq First North Bond Market any other regulated market or multilateral trading facility on which the Bonds are from time to time admitted to trading;
- inclusion of an admission to trading and maintenance of listing general undertaking of the Issuer with respect to the Bonds and any Subsequent Bonds issued; and
- inclusion of a project specific undertaking, whereby the Issuer shall procure that Minority Projects (as defined in the proposed amended Terms and Conditions), which are projects owned (directly or indirectly) by Gefion Group Holdco III A/S with an ownership of shares or ownership rights representing less than twenty (20) per cent. (i) are subject to a monthly management fee of maximum DKK 200,000 payable by the relevant Minority Project to a Group Company or the Guarantor to cover operating expenses of such Minority Projects and (ii) if any such Minority Projects are subject to management fees higher than what is mentioned under paragraph (i) above, that such excess management fees are reinvested into equity in the relevant Minority Project or paid into the Blocked Account and used for partial redemption of the Bonds, subject to the Minimum Redemption Amount being met.

Miscellaneous

In addition to the above, the Issuer is proposing that the Bondholders kindly agree to:

1. authorise the Agent to (on behalf of the Bondholders) take all such steps as may be deemed necessary or desirable to implement the Proposal and/or to achieve its purpose, to execute and enter into any documents that may be necessary in connection with the Proposal including any consequential amendments to the Terms and Conditions, under the strict acknowledgment that the Agent will not be held liable by the Bondholders for the exercise by the Agent of any of its rights and powers given to it under this paragraph; and
2. acknowledge the limitation of liability set out in above under the heading "LIMITATION OF LIABILITY OF THE AGENT".

The request for approvals, consents and waiver set out in this paragraph 2 above are jointly referred to as the "**Proposal**".

B. Consent fee

1. Consent fee



Subject to satisfaction of the conditions set forth in paragraph 2 (*Fee conditions*), if the Proposal is approved by the Bondholders under the Written Procedure, the Issuer will pay a consent fee (the "**Consent Fee**") to all Bondholders (regardless if such Bondholder has participated in the Written Procedure or voted for or against the Proposal). The Consent Fee will be an amount equal to one point five (1.50) per cent. of the Nominal Amount of each Bond.

The Consent Fee will be settled through an increase of the Redemption Premium payable in relation to each SEK and EUR Bond in an amount equal to the Consent Fee payable per Bond (the "**Consent Fee Increase**"), as further described in the section "*Interest Payments and Redemption Premium*" above.

The Agent does not administer the Consent Fee and is not involved in or in any way responsible for the Consent Fee.

2. Fee conditions

Payment of the Consent Fee as stated in paragraph 1 (*Consent fee*) is conditional upon the quorum and majority requirements being satisfied such that the Proposal is approved in the Written Procedure.

3. Payment of fees

The Consent Fee will be settled through the increase of the Redemption Premium payable for each SEK and EUR Bond at redemption of such Bonds in an amount equal to the Consent Fee Increase. The settlement of the Consent Fee through the increase of the Redemption Premium is expected to be made without withholding or deduction for any applicable taxes and each Bondholder must make its own determination as to whether or not it is required to pay tax as a result of it receiving Consent Fee by way of the Consent Fee Increase of the Redemption Premium in connection with the Proposal.

C. Effective Date

The Proposal shall be deemed approved immediately upon expiry of the voting period and satisfaction of the requisite quorum participation and majority vote as set forth under the headings "*Quorum*" and "*Majority*" in Section D (*Decision procedure*) below, or if earlier, when a requisite majority of consents of the total Adjusted Nominal Amount have been received by the Agent, and, subject to the Agent having received all documents and confirmations it reasonably considers necessary to implement the Proposal, the Proposal shall come into effect on the date the Issuer and the Agent enters into an amendment and restatement agreement (the "**ARA**") for the purpose of amending and restating the Terms and Conditions (the "**Effective Date**"), save that the amendments proposed under the heading "*Interest Payments and Redemption Premium*" in paragraph 2 (*Proposal and request for waiver*) Section A (*Background and Proposal*) shall, subject to the requirements specified above (including the execution of the ARA), be deemed to have taken effect from (but excluding) the Interest Payment Date that occurred on 11 August 2026) (the "**Interest Effective Date**")

The Issuer and the Agent shall, in order to implement the Proposed Amendments, enter into the ARA to amend and restate the Terms and Conditions for the Bonds. The Issuer and the Agent may agree to take any further action deemed necessary in order to implement the Proposal.

D. Decision procedure

The Agent will determine whether replies received are eligible to participate in the Written Procedure, continuously calculate the replies provided in respect of the Proposal and determine the result of the Written Procedure as soon as possible based thereon.

Once a requisite majority of consents of the total Adjusted Nominal Amount in the Written Procedure have been received by the Agent, the relevant decision shall be deemed to be adopted, even if the time period for replies in the Written Procedure has not yet expired.

Information about the decision taken in the Written Procedure will be sent by notice to the Bondholders, published on the websites of the Issuer and the Agent and published by way of press release by the Issuer.

Minutes from the Written Procedure shall at the request of a Bondholder be sent to it by the Issuer or the Agent, as applicable.

IF THE PROPOSAL IS APPROVED BY THE WRITTEN PROCEDURE IT WILL BE BINDING ON ALL BONDHOLDERS WHETHER THEY PARTICIPATED IN THE WRITTEN PROCEDURE OR VOTED AGAINST THE PROPOSAL OR NOT, IN ACCORDANCE WITH THE TERMS AND CONDITIONS.

Voting rights

Anyone who wishes to participate in the Written Procedure must on the Record Date:

- (i) be registered on the Securities Account as a direct registered owner (*Sw. direktregistrerad ägare*); or
- (ii) be registered on the Securities Account as authorised nominee (*Sw. förvaltare*),

with respect to one or several Bonds.

If you are not registered as a direct registered owner, but your Bonds are held through a registered authorised nominee (*Sw. förvaltare*) or another intermediary, you may have two different options to influence the voting for the Bonds.

1. Definitions and Construction

1.1 Definitions

In these [amended and restated](#) terms and conditions (the "**Terms and Conditions**"):

"Account Operator" means a bank or other party duly authorised to operate as an account operator pursuant to the Financial Instruments Accounts Act and through which a Bondholder has opened a Securities Account in respect of its Bonds.

"Accrued But Unpaid Interest" means any Interest accrued from (but excluding) the First Issue Date that (i) has not been paid in cash on an Interest Payment Date or (ii) does not constitute Deferred Interest. For the avoidance of doubt, any Interest capitalised up to (and including) the Interest Amendment Effective Date (i.e. any Interest not payable in cash at Interest Payment Dates prior to (and including) the Interest Amendment Effective Date) has been converted to Deferred Interest.

"Acquisition Facility" means any debt facility incurred for the purposes of financing Permitted Acquisitions.

"Adjusted Nominal Amount" means the Total Nominal Amount less the Nominal Amount of all Bonds owned by a Group Company or an Affiliate, irrespective of whether such Person is directly registered as owner of such Bonds.

"Advance Purchase Agreements" means (a) an advance or deferred purchase agreement if the agreement is in respect of the supply of assets or services and payment in the normal course of business with credit periods which are normal for the relevant type of project contracts, or (b) any other trade credit incurred in the ordinary course of business when payment is due no more than 90 days of the date of trade.

"Affiliate" means any Person, directly or indirectly, controlling or controlled by or under direct or indirect common control with such specified Person. For the purpose of this definition, **"control"** when used with respect to any Person means the power to direct the management and policies of such Person, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise; and the terms **"controlling"** and **"controlled"** have meanings correlative to the foregoing.

"Agency Agreement" means the agency agreement entered into on or prior to the First Issue Date, between the Issuer and the Agent, or any replacement agency agreement entered into after the First Issue Date between the Issuer and an agent.

"Agent" means [CSC \(Sweden\) AB \(name changed from](#) Intertrust (Sweden) AB), reg. no. 556625-5476, P.O. Box 16285, SE-103 25 Stockholm, Sweden or another party replacing it, as Agent, in accordance with these Terms and Conditions.

"Amendment Effective Date" means [\[**\] 2026.](#)

"Arranger" means SIP Nordic Fondkommission AB, Kungsgatan 27, 111 56 Stockholm, Sweden.

"Available Distribution Redemption Amount" shall have the meaning set forth in Clause 9.6(b).

"Available Divestment Redemption Amount" shall have the meaning set forth in Clause 9.5(b).

"Bond" means a SEK Bond and/or a EUR Bond.

"Bondholder" means the Person who is registered on a Securities Account as direct registered owner (Sw. *ägare*) or nominee (Sw. *förvaltare*) with respect to a Bond.

"Bondholders' Meeting" means a meeting among the Bondholders held in accordance with Clause 17 (*Bondholders' Meeting*).

"Bond Issue" means the Initial Bond Issue and any Subsequent Bond Issue.

"Business Day" means a day in Sweden other than a Sunday or other public holiday and on which day the Swedish CSD settlement system is open and banks in Denmark are open for general banking business and which, in relation to any date for payment or purchase of EUR, is a TARGET Day. Saturdays, Midsummer Eve (Sw. *midsommarafton*), Christmas Eve (Sw. *julafton*) and New Year's Eve (Sw. *nyårsafton*) shall for the purpose of this definition be deemed to be public holidays.

"Business Day Convention" means the first following day that is a Business Day unless that day falls in the next calendar month, in which case that date will be the first preceding day that is a Business Day.

~~"Call Option Amount" mean the amount set out in Clause 9.3 (Voluntary Total Redemption (Call Option)), as applicable.~~

"Cash and Cash Equivalents" means, at any time, (a) cash in hand held by a Group Company or with a reputable bank credited to an account in the name of a Group Company and in each case to which that Group Company is beneficially and legally entitled and which is immediately available to be applied in repayment or prepayment of the Bonds or payment of interest (for the avoidance of doubt, not including e.g. any cash subject to a pledge or similar arrangement or cash that a Group Company is required to hold pursuant to any credit agreement (excluding legal right to set-off) or any amount standing on client accounts) and (b) short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value for the Issuer or the Guarantor.

"Change of Control Event" means the occurrence of an event or series of events whereby one or more persons, not being the Guarantor, acting together, acquire control over the Issuer and where "control" means (a) acquiring or controlling, directly or indirectly, more than 50 per cent. of the voting shares of the Issuer, or (b) the right to, directly or indirectly, appoint or remove all or a majority of the directors of the board of directors of the Issuer.

"Compliance Certificate" means a certificate to the Agent, in the agreed form between the Agent and the Issuer, signed by the Issuer certifying (as applicable):

- (a) that so far as it is aware no Event of Default is continuing or, if it is aware that such event is continuing, specifying the event and steps, if any, being taken to remedy it; and/or
- (b) if the Compliance Certificate is provided in connection with an Incurrence Test, that the Incurrence Test is met (including figures in respect of the relevant financial tests and the basis on which they have been calculated).

"Construction Facility" means any construction facility (loans or bonds) incurred by a Subsidiary of the Issuer to finance the development and construction of any property owned or to be acquired by such Subsidiary.

"Corporate Finance Advisor" means Vinga Corporate Finance AB.

"CSD" means the Issuer's central securities depository and registrar in respect of the Bonds, from time to time, initially Euroclear Sweden AB, reg. no. 556112-8074, P.O. Box 191, 101 23 Stockholm, Sweden.

"CSD Agent" means the legal entity appointed by the Issuer to act as its paying agent and/or issuing agent with respect to the Bonds in the CSD.

"Danish Capital Markets Act" means the Danish Consolidated Act No. ~~2014~~⁴⁶⁴ of 1 ~~November~~^{May} 2021¹⁶ on capital markets, as amended and supplemented from time to time (in Danish: *Lov om kapitalmarkeder*).

"Deferred Interest" means the accrued but unpaid portion of the interest rate that capitalised on each Interest Payment Date up to (and including) the Interest Amendment Effective Date (i.e. any Interest not payable in cash on Interest Payment Dates prior to (and including) the Interest Amendment Effective Date), which shall be deferred in accordance with Clause 8(d), equal to an amount as set out in Clauses 8(e) and 8(f), less (if and to the extent applicable) any partial amount repaid in accordance with Clause 9.4 (*Voluntary partial redemption*), Clause 9.5 (*Mandatory partial redemption upon divestments*) or Clause 9.6 (*Mandatory partial redemption upon Project Distribution*).

"Divestment Proceeds" means cash proceeds received as part of the purchase in connection with any divestment of a project.

"Divestment Net Proceeds" means Divestment Proceeds less taxes relating to the relevant divestment and transaction costs relating to the relevant divestment (other than to the extent not already deducted from Divestment Net Proceeds already received in relation to the relevant project). For the avoidance of doubt, any deferred purchase price, vendor financing or similar shall not constitute Divestment Net Proceeds until the cash of such has been received by the relevant Group Company.

"DKK" or "Danish Krone" means the lawful currency of Denmark.

"Downstream Loans" means any current or future downstream loans from the Issuer to any direct Subsidiary of the Issuer.

"Escrow Account" means a EUR bank account and/or SEK bank account opened by the Arranger with a reputable bank, on which the proceeds from a Bond Issue will be held

"**Event of Default**" means an event or circumstance specified in any of the Clauses 14.1 (*Non-Payment*) to and including Clause 14.9 (*Continuation of the Business*).

"**Existing Bonds**" means the Issuer's existing bond issue of up to DKK 400,000,000, 2018/2022.

"**Extension Option**" shall have the meaning set forth in Clause 9.1(b).

"**Final Maturity Date**" means 11 November 2025⁸, subject to the Extension Option.

"**Finance Documents**" means:

- (a) these Terms and Conditions;
- (b) the Agency Agreement;
- (c) the Security Documents;
- (d) the Guarantee Agreement; and

- (e) any other document designated to be a Finance Document by the Issuer and the Agent or the Security Agent.

"Finance Leases" means any finance leases, to the extent the arrangement is or would have been treated as a finance or a capital lease in accordance with the accounting principles applicable on the First Issue Date (a lease which in the accounts of the Group is treated as an asset and a corresponding liability), and for the avoidance of doubt, any leases treated as operating leases under the accounting principles as applicable on the First Issue Date shall not, regardless of any subsequent changes or amendments of the accounting principles, be considered as a finance or capital lease.

"Financial Indebtedness" means any indebtedness in respect of:

- (a) monies borrowed or raised, including Market Loans;
- (b) the amount of any liability in respect of any Finance Leases;
- (c) receivables sold or discounted (other than any receivables to the extent they are sold on a non-recourse basis);
- (d) any amount raised under any other transaction (including any forward sale or purchase agreement) having the commercial effect of a borrowing;
- (e) any derivative transaction entered into in connection with protection against or benefit from fluctuation in any rate or price (and, when calculating the value of any derivative transaction, only the mark to market value shall be taken into account, provided that if any actual amount is due as a result of a termination or a close-out, such amount shall be used instead);
- (f) any counter indemnity obligation in respect of a guarantee, indemnity, bond, standby or documentary letter of credit or any other instrument issued by a bank or financial institution; and

The ~~T~~otal ~~N~~ominal ~~A~~mount of the Initial Bonds is the SEK and EUR equivalent of approximately DKK 200,000,000. All Initial Bonds are issued on a fully paid basis at an issue price of 97.00 per cent. of the Initial Nominal Amount. Bonds may be sold on further discount to larger investors, subject to agreement between the Issuer and the Arranger.
- (d) The minimum permissible investment in the Initial Bond Issue is SEK 1,250,000. (or at least the SEK equivalent of EUR 100,000) and EUR 100,000, respectively.
- (e) Provided that the Incurrence Test is met (calculated pro forma including such issue), the Issuer may, at one or several occasions, issue Subsequent Bonds (each such issue, a "**Subsequent Bond Issue**"). Subsequent Bonds shall benefit from and be subject to the Finance Documents, and, for the avoidance of doubt, the ISIN, the Interest Rate, the Nominal Amount and the Final Maturity Date applicable to the Initial Bonds shall apply to Subsequent Bonds. The price of the Subsequent Bonds may be set at a discount or at a premium compared to the Nominal Amount. The maximum total nominal amount of the Bonds (the Initial Bonds and all Subsequent Bonds) may not exceed the DKK 500,000,000 equivalent in SEK or EUR (as applicable) unless a consent from the Bondholders is obtained in accordance with Clause 16(e)(i). Each Subsequent Bond shall entitle its holder to Interest in accordance with Clause 8(a) and Deferred Interest in accordance with Clause 8(a)~~f~~, and otherwise have the same rights as the Initial Bonds.
- (f) The Bonds constitute direct, general, unconditional, unsubordinated and secured obligations of the Issuer and shall at all times rank (i) without any preference among them and (ii) at least *pari passu* with all direct, unconditional, unsubordinated and unsecured obligations of the Issuer, except those obligations which are mandatorily preferred by law.
- (g) The Bonds are freely transferable but the Bondholders may be subject to purchase or transfer restrictions with regard to the Bonds, as applicable, under local laws to which a Bondholder may be subject. Each Bondholder must ensure compliance with such restrictions at its own cost and expense.
- (h) No action is being taken in any jurisdiction that would or is intended to permit a public offering of the Bonds or the possession, circulation or distribution of any

document or other material relating to the Issuer or the Bonds in any jurisdiction other than Sweden, where action for that purpose is required. Each Bondholder must inform itself about, and observe, any applicable restrictions to the transfer of material relating to the Issuer or the Bonds.

- (i) Euroclear Sweden AB, shall perform its obligations as CSD in respect of the Bonds and in accordance with the rules and regulations for issuers and issuing agents as regularly applied to it in relation to Swedish bond offerings.

3. Use of Proceeds

3.1 Use of Proceeds

- (a) The proceeds from the Initial Bond Issue shall be used to:
 - (i) finance Transaction Costs;
 - (ii) refinancing of the Existing Bonds;
 - (iii) financing of costs under the Management Agreement;
 - (iv) finance interest payments under the Bonds and guarantee premiums under the Guarantee;
 - (v) finance Permitted Acquisitions;
 - (vi) finance dividend payments to the Guarantor for the financing of tax liabilities in the Guarantor; and
 - (vii) finance working capital and general corporate purposes of the Group.
- (b) The proceeds from any Subsequent Bond Issue shall be used to:
 - (i) finance Transaction Costs;
 - (ii) financing of costs under the Management Agreement;
 - (iii) finance interest payments under the Bonds and guarantee premiums under the Guarantee;
 - (iv) finance Permitted Acquisitions; and
 - (v) finance working capital and general corporate purposes of the Group.

4. Conditions Precedent

4.1 The Escrow Account

The Net Proceeds from a Bond Issue shall be held by the Arranger on the Escrow Account and shall be released to the Issuer when the conditions precedent for disbursement of the Net Proceeds for the Bonds have been fulfilled pursuant to Clause 4.2 (*Conditions*

Precedent for Disbursement of Net Proceeds from the Initial Bonds) or Clause 4.3 (*Conditions Precedent for Disbursement in connection with Subsequent Bond Issues*), as applicable.

4.2 Conditions Precedent for Disbursement of Net Proceeds from the Initial Bonds

- (a) The Agent's approval of the disbursement from the Escrow Account of the Net Proceeds from the Initial Bond Issue is subject to the following documents being received by the Agent, in form and substance satisfactory to it (acting reasonably), and that the following actions have been taken or will occur on the disbursement date:
 - (i) constitutional documents and corporate resolutions (approving the relevant Finance Documents and authorising a signatory/-ies to execute the Finance Documents) for the Issuer and each other party to a Finance Document (other than the Agent and the Security Agent), together constituting evidence that the Finance Documents have been duly executed;
 - (ii) copies of the Finance Documents, duly executed by each party thereto;
 - (iii) evidence that, the Transaction Security either has been or will immediately following disbursement from the Escrow Account be perfected in accordance with the terms of the Finance Documents;
 - (iv) a CP satisfaction letter from a Danish law firm confirming that the Danish law legal conditions precedent for disbursement are fulfilled;
 - (v) legal opinion(s) on the capacity and due execution of a party (other than the Agent) to a Finance Document issued by a reputable law firm; and
 - (vi) legal opinion(s) on the validity and enforceability of any Finance Document not governed by Swedish law issued by a reputable law firm.
- (b) The Agent may assume that the documentation and evidence delivered to it pursuant to Clause 4.2(a) is accurate, legally valid, enforceable, correct, true and complete unless it has actual knowledge to the contrary and the Agent does not have to verify or assess the contents of any such documentation. The Agent does not have any obligation to review the documentation and evidence referred to in Clause 4.2(a) above from a legal or commercial perspective of the Bondholders.
- (c) When the conditions precedent for disbursement set out in Clause 4.2(a) have been fulfilled to the satisfaction of the Agent (acting reasonably) or waived by the Agent, the Agent shall notify the Arranger that the Net Proceeds shall be released from the Escrow Account, to be applied as set out in Clause 3.1 (*Use of Proceeds*), and the Arranger shall thereafter or in connection therewith release the Net Proceeds from the Escrow Account.
- (d) Net Proceeds may be released partially to be applied for Transaction Costs and refinancing of the Existing Bonds.

- (e) If the conditions precedent for disbursement have not been fulfilled to the satisfaction of the Agent (acting reasonably) or waived by the Agent within sixty (60) Business Days from the First Issue Date, the Issuer shall repurchase all Bonds at a price equal to 100 per cent. of the Initial Nominal Amount together with any accrued Interest. The funds on the Escrow Account shall in such case be applied to repurchase the Bonds on behalf of the Issuer. Any shortfall shall be covered by the Issuer.

4.3 Conditions Precedent for Disbursement in connection with Subsequent Bond Issues

- (a) The Agent's approval of the disbursement from the Escrow Account of the Net Proceeds from a Subsequent Bond Issue is subject to the following documents being received by the Agent, in form and substance satisfactory to it (acting reasonably), and that the following actions have been taken or will occur on the disbursement date:
 - (i) to the extent applicable, constitutional documents and corporate resolutions (approving the relevant Finance Documents and authorising a signatory/-ies to execute the Finance Documents) for the Issuer and each other party to a Finance Document (other than the Agent and the Security Agent), together constituting evidence that the Finance Documents have been duly executed;
 - (ii) to the extent applicable, copies of the Finance Documents, duly executed by each party thereto;
 - (iii) to the extent applicable, evidence that the Transaction Security either has been or will immediately following disbursement from the Escrow Account be perfected in accordance with the terms of the Finance Documents;
 - (iv) a CP satisfaction letter from a Danish law firm confirming that the Danish law legal conditions precedent for disbursement are fulfilled;
 - (v) to the extent applicable, legal opinion(s) on the capacity and due execution of a party (other than the Agent) to a Finance Document issued by a reputable law firm; and
 - (vi) to the extent applicable, legal opinion(s) on the validity and enforceability of any Finance Document not governed by Swedish law issued by a reputable law firm.
- (b) The Agent may assume that the documentation and evidence delivered to it pursuant to Clause 4.3(a) is accurate, legally valid, enforceable, correct, true and complete unless it has actual knowledge to the contrary and the Agent does not have to verify or assess the contents of any such documentation. The Agent does not have any obligation to review the documentation and evidence referred to in Clause 4.3(a) above from a legal or commercial perspective of the Bondholders.

- (c) When the conditions precedent for disbursement set out in Clause 4.3(a) have been received to the satisfaction of the Agent (acting reasonably), the Agent shall notify the Arranger that the Net Proceeds shall be released from the Escrow Account, to be applied as set out in Clause 3.1 (*Use of Proceeds*), and the Arranger shall thereafter or in connection therewith release the Net Proceeds from the Escrow Account.

5. Bonds in Book-Entry Form

- (a) The Bonds will be registered for the Bondholders on their respective Securities Accounts and no physical notes will be issued. Accordingly, the Bonds will be registered in accordance with the Financial Instruments Accounts Act. Registration requests relating to the Bonds shall be directed to an Account Operator.
- (b) The Issuer shall at all times ensure that the registration of the Bonds in the CSD is correct.
- (c) Those who according to assignment, Security, the provisions of the Swedish Children and Parents Code (Sw. *föräldrabalken (1949:381)*), conditions of will or deed of gift or otherwise have acquired a right to receive payments in respect of a Bond shall register their entitlements to receive payment in accordance with the Financial Instruments Accounts Act.
- (d) The Issuer (and the Agent and/or the CSD Agent when permitted under the CSD's applicable regulations) shall be entitled to obtain information from the debt register (Sw. *skuldbok*) and/or securities depositary kept by the CSD in respect of the Bonds. At the request of the Agent, the Issuer shall promptly obtain such information and provide it to the Agent.
- (e) For the purpose of or in connection with any Bondholders' Meeting or any Written Procedure, the CSD Agent shall be entitled to obtain information from the debt register kept by the CSD in respect of the Bonds.
- (f) The Issuer shall issue any necessary power of attorney to such Persons employed by the Agent, as notified by the Agent, in order for such individuals to independently obtain information directly from the debt register kept by the CSD in respect of the Bonds. The Issuer may not revoke any such power of attorney unless directed by the Agent or unless consent thereto is given by the Bondholders.

6. Right to Act on Behalf of a Bondholder

- (a) If any Person other than a Bondholder wishes to exercise any rights under the Finance Documents, it must obtain a power of attorney or other proof of authorisation from the Bondholder or a successive, coherent chain of powers of attorney or proofs of authorisation starting with the Bondholder and authorising such Person.

- (b) A Bondholder may issue one or several powers of attorney or other authorisation to third parties to represent it in relation to some or all of the Bonds held by it. Any such representative may act independently under the Finance Documents in relation to the Bonds for which such representative is entitled to represent the Bondholder and may further delegate its right to represent the Bondholder by way of a further power of attorney.
- (c) The Agent shall only have to examine the face of a power of attorney or other proof of authorisation that has been provided to it pursuant to Clause 6(b) and may assume that it has been duly authorised, is valid, has not been revoked or superseded and that it is in full force and effect, unless otherwise is apparent from its face.

7. Payments in Respect of the Bonds

- (a) Any payment or repayment under the Finance Documents, or any amount due in respect of a repurchase of any Bonds, shall be made to such Person who is registered as a Bondholder on the Record Date prior to an Interest Payment Date or other relevant due date, or to such other Person who is registered with the CSD on such date as being entitled to receive the relevant payment, repayment or repurchase amount.
- (b) If a Bondholder has registered, through an Account Operator, that principal, interest or any other payment shall be deposited in a certain bank account, such deposits will be effected by the CSD on the relevant payment date. Should the CSD, due to a delay on behalf of the Issuer or some other obstacle, not be able to effect payments as aforesaid, the Issuer shall procure that such amounts are paid to the Persons who are registered as Bondholders on the relevant Record Date as soon as possible after such obstacle has been removed.
- (c) If, due to any obstacle for the CSD, the Issuer cannot make a payment or repayment, such payment or repayment may be postponed until the obstacle has been removed. Interest shall accrue without any default interest in accordance with Clause 8(c) during such postponement.
- (d) If payment or repayment is made in accordance with this Clause 7, the Issuer and the CSD shall be deemed to have fulfilled their obligation to pay, irrespective of whether such payment was made to a Person not entitled to receive such amount.
- (e) The Issuer is not liable to gross-up any payments under the Finance Documents by virtue of any withholding tax, public levy or the similar.

8. Interest

- (a) Each Initial Bond carries Interest at the Interest Rate from (but excluding) the First Issue Date up to (and including) the relevant Redemption Date. Any Subsequent Bond will, with the exception set forth in Clause 8(f) below, carry Interest at the Interest Rate from (but excluding) the Interest Payment Date

falling immediately prior to its issuance (or the First Issue Date if there is no such Interest Payment Date) up to (and including) the relevant Redemption Date.

- (b) Interest accrues during an Interest Period. Payment ~~and capitalization of~~ Interest ~~shall be made as follows:~~
 - (i) ~~up until 11 November 2026, of the total Interest Rate, (A) an amount equal to 2.00 per cent *per annum* shall be paid to the Bondholders on each Interest Payment Date for the preceding Interest Period and (B) the remaining amount of accrued Interest shall be capitalized on each Interest Payment Date (and thereafter carry Interest) (the "PIK Interest") and payment of the PIK Interest shall be deferred until the Final Maturity Date (as extended); and~~
 - (ii) ~~as from 12 November 2026, Interest~~ in respect of the Bonds shall be ~~paid~~made to the Bondholders on each Interest Payment Date ~~until the Final Maturity Date~~ for the preceding Interest Period.
- (c) Interest shall be calculated on the basis of the actual number of days in the Interest Period in respect of which payment is being made divided by 360 (actual/360-days basis).
- (d) On the Interest Payment Dates falling up to (and including) the Interest Amendment Effective Date, the Issuer shall defer all of the Deferred Interest with the effect that such Deferred Interest shall be paid (in whole or in part) upon redemption of the Bonds as further set out in Clause 9 (Redemption and Repurchase of the Bonds).
- (e) Deferred Interest in a total amount of SEK 96,098,261 for the SEK Bonds and EUR 8,535,187 for the EUR Bonds up to (and including) the Interest Amendment Effective Date shall be considered as Deferred Interest from the Interest Amendment Effective Date.
- (f) Any Subsequent Bonds issued after the Interest Amendment Effective Date shall be entitled to receive Deferred Interest in an amount corresponding to 33.40 per cent. of the Nominal Amount per SEK Bond and in an amount corresponding to 35.56 per cent. of the Nominal Amount per EUR Bond.
- (g) The CSD shall not be responsible for the calculation of any Deferred Interest. Before any interest payment, redemption and/or partial prepayment of the Bonds, the Issuer shall provide the CSD with such calculations, in accordance with the applicable rules and regulations of the CSD in order to establish with the CSD the correct amount to be paid, redeemed and/or partially prepaid under these Terms and Conditions.
- (h) ~~(d)~~ If the Issuer fails to pay any amount payable by it on its due date, default interest shall accrue on the overdue amount from (but excluding) the due date up to (and including) the date of actual payment at a rate which is five (5) per cent. higher than the Interest Rate. Accrued default interest shall not be capitalised. No default interest shall accrue where the failure to pay was solely

attributable to the Agent or the CSD, in which case the Interest Rate shall apply instead.

9. Redemption and Repurchase of the Bonds

9.1 Redemption at Maturity and Extension Option

- (b) The Issuer shall have an option to extend the original Final Maturity Date ~~twice~~ one time for a total extension of twelve (12) ~~months plus twelve (12)~~ months, by giving notice to the Agent and the Bondholders at least thirty (30) Business Days prior to the original Final Maturity Date ~~(falling on 11 November 2025) and (30) Business Days before the second extended Final Maturity Date (falling on 11 November 2026 (if extended) (the "Second Extension Option"), provided in each case that no Event of Default is continuing on the date when the Issuer gives written notice (the "Extension Option").~~

9.2 Issuer's Purchase of Bonds

The Issuer may, subject to applicable law, at any time and at any price purchase Bonds on the market or in any other way. The Bonds held by the Issuer may at the Issuer's discretion be retained, sold or cancelled.

9.3 Voluntary Total Redemption (Call Option)

- (a) The Issuer may redeem all, but not only some, of the outstanding Bonds in full at any time:
 - ~~(i) if the Call Option is exercised before the date falling 12 months after the First Issue Date at an amount per Bond equal to the sum of (i) 105.0 per cent. of the Nominal Amount and, (ii) any accrued but unpaid interest up to the redemption date; and~~ 100 per cent. of the Deferred Interest, plus (iii) the applicable Redemption Premium, and (iv) Accrued But Unpaid Interest.
 - ~~(ii) if the Call Option is exercised on or after the date falling 12 months after the First Issue Date at an amount per Bond equal to the sum of (i) 103.00 per cent. of the Nominal Amount and (ii) accrued but unpaid interest up to the redemption date.~~
- (b) Redemption in accordance with Clause 9.3(a) shall be made by the Issuer giving not less than fifteen (15) Business Days' notice to the Bondholders and the Agent. The notice shall specify the Redemption Date and also the Record Date

on which a person shall be registered as a Bondholder to receive the amounts due on such Redemption Date. Any such notice is irrevocable but may, at the Issuer's discretion, contain one or more conditions precedent. Upon expiry of such notice and the fulfillment of the conditions precedent (if any), the Issuer is bound to redeem the Bonds in full at the applicable amounts.

- (c) The relevant record date shall be agreed upon between the Issuer, the CSD and the Agent in connection with such repayment.

9.4 Voluntary partial redemption

The repayment must occur on an Interest Payment Date.
- (b) Partial redemption in accordance with this Clause 9.4 shall be made by the Issuer giving not less than fifteen (15) Business Days' notice to the Bondholders and the Agent. Any such notice is irrevocable and, upon expiry of such notice, the Issuer is bound to redeem the Bonds in part on the immediately following Interest Payment Date at the applicable amounts. The applicable amount shall be an even amount in SEK and EUR (as applicable) and paid to the Person who is registered as a Bondholder on the Record Date prior to the relevant Redemption Date.

9.5 Mandatory partial redemption upon divestments

- (a) Subject to paragraph (b) and (c) below, the Issuer shall ensure that upon the receipt of any Divestment Proceeds, all or part of the Divestment Net Proceeds as further specified in paragraph (b) below are used to partially redeem the Bonds by applying the relevant portion of the Divestment Net Proceeds towards reducing the Nominal Amount of each Bond *pro rata*. The repayment per Bond shall equal the repaid percentage of (i) 100 per cent. of the Nominal Amount (rounded down to the nearest SEK or EUR 1.00), (ii) 100 per cent. of the Deferred Interest (rounded down to the nearest SEK or EUR 1.00), plus (iii) the applicable Redemption Premium, and (iv) Accrued But Unpaid Interest. The Issuer shall make any mandatory prepayment pursuant to this Clause 9.5 without undue delay as further specified in paragraph (e) below.
- (b) A partial redemption pursuant to this Clause 9.5 in relation to a project divested shall be in an amount equal to 100.00 per cent. of the Post-Receipt Closing Cash

Position that exceeds DKK 50,000,000 (the "Available Divestment Redemption Amount").

- (c) The Issuer shall be responsible for making the calculations to decide the Post-Receipt Closing Cash Position and the Available Divestment Redemption Amount pursuant to paragraph (b) above (and the Agent shall not be responsible to verify such calculations). If, and only if, the Available Divestment Redemption Amount is less than the Minimum Redemption Amount (taking into consideration any Available Divestment Redemption Amount or Available Distribution Redemption Amount standing to the credit on the Blocked Account), then the Available Divestment Redemption Amount shall be paid to the Blocked Account and be utilised for redemption and if the Minimum Redemption Amount is met (taking into consideration all Available Divestment Redemption Amount and Available Distribution Redemption Amount standing to the credit on the Blocked Account as well as any reduction due to the execution of a Permitted Reinvestment), the Issuer shall promptly, and in any case within ten (10) Business Days after the Minimum Redemption Amount has been met, by written notice to the Agent, request that all such available funds (meaning, for the avoidance of doubt, all Available Divestment Redemption Amounts and Available Distribution Redemption Amounts credited to the Blocked Account) are released from the Blocked Account in order to partially redeem the Bonds.
- (d) The Issuer shall in its request to the Agent include a certificate, duly executed by authorised representatives of the Issuer, pursuant to which the Issuer certifies that the funds requested to be released from the Blocked Account will be used in accordance with paragraph (c) above. For the avoidance of doubt, the Agent's consent, given in the Agent's sole discretion, shall be required for the release of funds from the Blocked Account in accordance with this Clause 9.5.
- (e) The mandatory partial redemption of Bonds pursuant to paragraph (a) above shall (i) be irrevocable, (ii) be made without undue delay (taking into account time required to upstream the relevant funds from Subsidiaries where relevant), however the Issuer shall always adhere to the notice period in subsection (iv) of this paragraph (e), (iii) include Accrued But Unpaid Interest and (iv) be made by the Issuer giving not less than fifteen (15) Business Days' notice to the Bondholders and the Agent, where such notice shall state the relevant Redemption Date on which the prepayment shall be made, the Divestment Net Proceeds and the relevant record date. The applicable amount shall be an even amount in SEK and EUR (as applicable) and paid to the Person who is registered as a Bondholder on the Record Date prior to the relevant Redemption Date.

9.6 Mandatory partial redemption upon Project Distribution

- (a) Subject to paragraph (b) and (c) below, the Issuer shall ensure that if and to the extent (i) a Group Company incurs any Acquisition Facility or Construction Facility (including by way of refinancing of any such facility) and (ii) the money received from the incurrence of such Permitted Debt are distributed from that Group Company to another Group Company (including to the Issuer) that is not a Subsidiary of such distributing Group Company, however, excluding payments

made in order to repay existing debt within such Group Company or its direct or indirect parent company (a "Project Distribution"), an amount equal to such Project Distribution, shall, subject to paragraph (b) below, be applied to partially redeem the Bonds by applying the relevant portion of the Project Distribution towards reducing the Nominal Amount of each Bond *pro rata*. The repayment per Bond shall equal the repaid percentage of (i) 100 per cent. of the Nominal Amount (rounded down to the nearest SEK or EUR 1.00), (ii) 100 per cent. of the Deferred Interest (rounded down to the nearest SEK or EUR 1.00), *plus* (iii) the applicable Redemption Premium, and (iv) Accrued But Unpaid Interest. The Issuer shall make any mandatory prepayment pursuant to this Clause 9.6 without undue delay as further specified in paragraph (e) below.

- (b) A partial redemption pursuant to this Clause 9.6 in relation to any Project Distribution shall be in an amount equal to 100.00 per cent. of the Post-Receipt Distribution Cash Position that exceeds DKK 50,000,000 (the "Available Distribution Redemption Amount").
- (c) The Issuer shall be responsible for making the calculations to decide the Post-Receipt Distribution Cash Position and the Available Distribution Redemption Amount pursuant to paragraph (b) above (and the Agent shall not be responsible to verify such calculations). If, and only if, the Available Distribution Redemption Amount is less than the Minimum Redemption Amount (taking into consideration any Available Divestment Redemption Amount or Available Distribution Redemption Amount standing to the credit on the Blocked Account), then the Available Distribution Redemption Amount shall be paid to the Blocked Account and be utilised for redemption and if the Minimum Redemption Amount is met (taking into consideration all Available Divestment Redemption Amount and Available Distribution Redemption Amount standing to the credit on the Blocked Account as well as any reduction due to the execution of a Permitted Reinvestment), the Issuer shall promptly, and in any case within ten (10) Business Days after the Minimum Redemption Amount has been met, by written notice to the Agent, request that all such available funds (meaning, for the avoidance of doubt, all Available Divestment Redemption Amounts and Available Distribution Redemption Amounts credited to the Blocked Account) are released from the Blocked Account in order to partially redeem the Bonds.
- (d) The Issuer shall in its request to the Agent include a certificate, duly executed by authorised representatives of the Issuer, pursuant to which the Issuer certifies that the funds requested to be released from the Blocked Account will be used in accordance with paragraph (c) above. For the avoidance of doubt, the Agent's consent, given in the Agent's sole discretion, shall be required for the release of funds from the Blocked Account in accordance with this Clause 9.6.
- (e) The mandatory partial redemption of Bonds pursuant to paragraph (a) above shall (i) be irrevocable, (ii) be made without undue delay (taking into account time required to upstream the relevant funds from Subsidiaries), however the Issuer shall always adhere to the notice period in subsection (iv) of this paragraph (e), (iii) include Accrued But Unpaid Interest and (iv) be made by the Issuer giving not less than fifteen (15) Business Days' notice to the Bondholders

and the Agent, where such notice shall state the relevant Redemption Date on which the prepayment shall be made, the amount of the Project Distribution and the relevant record date. The applicable amount shall be an even amount in SEK and EUR (as applicable) and paid to the Person who is registered as a Bondholder on the Record Date prior to the relevant Redemption Date.

9.7 9.5 Mandatory Repurchase due to a Change of Control Event (Put Option)

- (a) Upon the occurrence of a Change of Control Event, each Bondholder shall have the right to request that all, or some only, of its Bonds be repurchased at a price per Bond equal to (i) ~~103.00~~100 per cent of the Nominal Amount, (ii) 100 per cent. of the Deferred Interest, plus (iii) the applicable Redemption Premium, and (iiiiv) aAccrued But Unpaid Interest}, during a period of twenty (20) Business Days following a notice from the Issuer of the Change of Control Event pursuant to Clause 11.1(c) (after which time period such rights lapse).
- (b) The notice from the Issuer pursuant to Clause 11.1(c) shall specify the repurchase date and include instructions about the actions that a Bondholder needs to take if it wants Bonds held by it to be repurchased. If a Bondholder has so requested, and acted in accordance with the instructions in the notice from the Issuer, the Issuer shall repurchase the relevant Bonds and the repurchase amount shall fall due on the repurchase date specified in the notice given by the Issuer pursuant to Clause 11.1(c). The repurchase date must fall no later than forty (40) Business Days after the end of the period referred to in ~~Clause~~paragraph 9.5(a) above.
- (c) The Issuer shall comply with the requirements of any applicable securities laws or regulations in connection with the repurchase of Bonds. To the extent that the provisions of such laws and regulations conflict with the provisions in this Clause ~~9.47~~, the Issuer shall comply with the applicable securities laws and regulations and will not be deemed to have breached its obligations under this Clause ~~9.47~~ by virtue of the conflict.
- (d) Any Bonds repurchased by the Issuer pursuant to this Clause ~~9.5~~9.7 may at the Issuer's discretion be retained, sold or cancelled.

9.8 9.6 Redemption Premium

For the avoidance of doubt, any redemption of the Bonds pursuant to this Clause ~~99~~, other than a purchase pursuant to paragraph ~~9.29.2~~ above, shall be made at ~~the a price~~ per Bond equal to (i) 100 per cent. of the Nominal Amount, or in connection with a partial redemption, the repaid percentage of the Nominal Amount (rounded down to the nearest SEK or EUR 1.00), (ii) 100 per cent. of the Deferred Interest, or in connection with a partial redemption, the repaid percentage of the Deferred Interest (rounded down to the nearest SEK or EUR 1.00), plus (iii) the applicable Redemption Premium, and (iv) Accrued But Unpaid Interest.

10. Transaction Security

10.1 Transaction Security

- (a) As continuing Security for the due and punctual fulfilment of the Secured Obligations, the Issuer and each Group Company party to any Security Document grants the Transaction Security to the Secured Parties as represented by the Security Agent on the terms set out in the Security Documents.
- (b) The Security Agent shall hold the Transaction Security on behalf of the Secured Parties in accordance with the Security Documents. The Issuer shall, and shall procure that each Group Company party to any Security Document will, enter into the Security Documents and perfect the Transaction Security in accordance with the Security Documents.
- (c) Unless and until the Security Agent has received instructions from the Bondholders in accordance with Clause 16 (*Decisions by Bondholders*), the Security Agent shall (without first having to obtain the Bondholders' consent) be entitled to enter into agreements with the Issuer or a third party or take any other actions, if it is, in the Security Agent's opinion, necessary for the purpose of maintaining, altering, releasing or enforcing the Transaction Security, creating further Security for the benefit of the Secured Parties or for the purpose of settling the Bondholders' or the Issuer's rights to the Transaction Security, in each case in accordance with the terms of the Finance Documents and provided that such agreements or actions are not detrimental to the interest of the Bondholders.

10.2 Additional Security Over New Downstream Loans

- (a) Upon the granting of any new Downstream Loan, the Issuer shall, to the extent not already assigned, assign its rights under such Downstream Loan as a first priority security for all amounts outstanding under the Finance Documents in favour of the Security Agent and simultaneously therewith deliver to the Agent constitutional documents and corporate resolutions (approving the relevant Security Document and authorising a signatory/-ies to execute the relevant Security Document) for the Issuer.
- (b) Upon the granting of a Downstream Loan, the Issuer undertakes to notify the Agent of such Downstream Loan and deliver a copy of the intercompany loan agreement.
- (c) Provided that no Event of Default has occurred and is continuing, payment of interest or principal under Downstream Loans may take place in each of the following situations:
 - (i) for the purpose of servicing the Issuer's payment obligations under the Bonds;
 - (ii) in connection with a permitted disposal (as described in Clause 13.5 (*Disposal of Assets*)) of the shares in a Subsidiary, provided that the

funds are deposited on a blocked account pledged in favour of the Agent, (the "**Blocked Account**") which may thereafter be released in the discretion of the Agent (acting reasonably) to finance the purposes set out in Clauses 3.1(b), 9.5(c), ~~3.19.6(b)~~ and financing Permitted Investments or Permitted Reinvestments; and

- (iii) otherwise with the written consent of the Security Agent.

11. Information to Bondholders

11.1 Information from the Issuer

- (a) The Issuer shall make the following information available in the English language by publication on the website of the Issuer:
 - (i) as soon as the same become available, but in any event within ~~five~~six (~~5~~6) months after the end of each financial year, the annual audited consolidated financial statements of the Group, including a consolidated profit and loss account and a cash statement for the Issuer and a management commentary or report from the Issuer's board of directors;
 - (ii) as soon as the same become available, but in any event within three (3) months after the end of each half-financial year, the semi-annual unaudited consolidated financial statements of the Group, including a profit and loss account and a cash statement for the Issuer; and
 - (iii) as soon as practicable following an acquisition or disposal of Bonds by a Group Company, the aggregate Nominal Amount held by Group Companies.
- (b) When the financial statements and other information are made available to the Bondholders pursuant to Clause 11.1(a), the Issuer shall send copies of such financial statements and other information to the Agent.
- (c) The Issuer shall promptly notify the Agent and the Bondholders upon becoming aware of the occurrence of a Change of Control Event and shall provide the Agent with such further information as the Agent may request (acting reasonably) following receipt of such notice. A notice regarding a Change of Control Event may be given in advance of the occurrence of a Change of Control Event, conditioned upon the occurrence of such Change of Control Event, if a definitive agreement is in place providing for a Change of Control Event.
- (d) The Issuer shall promptly notify the Agent (with full particulars) upon becoming aware of the occurrence of any event or circumstance which constitutes an Event of Default, or any event or circumstance which would (with the expiry of a grace period, the giving of notice, the making of any determination or any combination of any of the foregoing constitute an Event of Default), and shall provide the Agent with such further information as it may reasonably request in writing following receipt of such notice. Should the Agent not receive such

information, the Agent is entitled to assume that no such event or circumstance exists or can be expected to occur, provided that the Agent does not have actual knowledge of such event or circumstance.

- (e) The Issuer shall submit a duly executed Compliance Certificate to the Agent in connection with the testing of the Incurrence Test.
- (f) The Agent may assume that any information provided by the Issuer in the Compliance Certificate delivered pursuant to paragraph (e) above is correct, and the Agent shall not be responsible or liable for the adequacy, accuracy or completeness of such information.
- (g) The Issuer shall within two (2) months after the end of each financial quarter provide the Agent with a quarterly management comment, including relevant information on the progress of the Issuer's projects as well as other key information, the management's fair value assessment of assets, debt position and a cashflow forecast comprising an opening balance and a liquidity forecast covering the next thirty-six (36) months, however not for a period after October 2026⁶⁸ or, if the Extension Option has been utilised, October 2029. The progress report shall also contain, in reasonable detail, a break-down of the fees paid for the period under the Management Agreement.
- (h) The Issuer is only obliged to inform the Agent according to this Clause 11.1 if informing the Agent would not conflict with any applicable laws.
- (i) The Issuer shall make the information referred to in this Clause 11.1 available, and shall otherwise publish and disclose all information, in the manner and within the time periods required by the Marketplace Rules for as long as any Bonds are admitted to trading on the Marketplace. To the extent the Marketplace Rules or applicable law require publication of the annual or semi-annual financial statements within a shorter period than set out in Clause 11.1(a)(i) and (ii), such shorter period shall prevail. Where there is any inconsistency between this Clause 11.1 and the Marketplace Rules, the Marketplace Rules shall prevail in respect of the publication of information to the holders of securities admitted to trading on the Marketplace.

11.2 Information from the Agent

- (a) Subject to applicable laws, regulations and the restrictions of a non-disclosure agreement entered into by the Agent in accordance with Clause 11.2(b), the Agent is entitled to disclose to the Bondholders any event or circumstance directly or indirectly relating to the Issuer or the Bonds. Notwithstanding the foregoing, the Agent may, if it considers it to be beneficial to the interests of the Bondholders, delay disclosure or refrain from disclosing certain information other than in respect of an Event of Default that has occurred and is continuing.
- (b) If a committee representing the Bondholders' interests under the Finance Documents has been appointed by the Bondholders in accordance with Clause 16 (*Decisions by Bondholders*), the members of such committee may agree with the Issuer not to disclose information received from the Issuer,

provided that it, in the reasonable opinion of such members, is beneficial to the interests of the Bondholders. The Agent shall be a party to such agreement and receive the same information from the Issuer as the members of the committee.

11.3 Publication of Finance Documents

- (a) The latest version of these Terms and Conditions (including any documents amending these Terms and Conditions) shall be available to the Bondholders on the websites of the Guarantor and the Agent.
- (b) The latest version of the Finance Documents (other than the Agency Agreement) shall be available to the Bondholders at the office of the Agent during the Agent's normal business hours.

12. Financial Undertakings

12.1 Incurrence Test

- (a) The Incurrence Test is met if:
 - (i) there is forecasted to be a minimum of 15,000,000 DKK, unrestricted liquidity in the Issuer during the coming twelve months from the relevant testing date;
 - (ii) the management of the Issuer has confirmed that the Issuer is able to continue as a "going concern" for the next twelve months following the delivery of the Compliance Certificate; and
 - (iii) no Event of Default is continuing or would occur upon the incurrence of new Financial Indebtedness or making of a Permitted Payment (as applicable).
- (b) When assessing the Issuer's ability to continue as a going concern pursuant to paragraph ~~(a)(ii)~~(a)(ii) above, the Issuer shall base its assessment on the accounting principles applicable to it and, in particular, the assessment shall take into consideration:
 - (i) the Issuer's current financial condition, including its liquidity sources at the date of the Compliance Certificate;
 - (ii) the Issuer's conditional and unconditional obligations due or anticipated within one year after the date of the Compliance Certificate;
 - (iii) the funds necessary to maintain the Issuer's operations considering its current financial condition, obligations, and other expected cash flows; and
 - (iv) any other conditions and events that may adversely affect the Issuer's ability to meet its obligations within one year after the date of the Compliance Certificate.

12.2 Testing of the Incurrence Test

- (a) The calculation of the Incurrence Test shall be made based on the figures in latest Quarterly Report adjusted to reflect any subsequent injection of equity or Subordinated Loan and before the incurrence of new Financial Indebtedness or making of a Permitted Payment (as applicable).
- (b) The shareholders of the Issuer may inject equity or Subordinated Loans into the Issuer prior to testing the Incurrence Test in order to meet the test before making a Subsequent Bond issue or Permitted Payment.

13. General Undertakings

13.1 General

The Issuer undertakes to (and shall, where applicable, procure that each other Group Company will) comply with the undertakings set out in this Clause 13 for as long as any Bonds remain outstanding.

13.2 Restricted Payments

- (a) The Issuer shall not, and shall procure that none of its Subsidiaries (unless to the Issuer or to another Group Company) will:
 - (i) pay any dividend in respect of its shares;
 - (ii) repurchase or redeem any of its own shares;
 - (iii) redeem or reduce its share capital or other restricted or unrestricted equity with repayment to its shareholders;
 - (iv) repay any Subordinated Loans or pay any interest thereon;
 - (v) make any prepayments or repayments under any long-term debt ranking junior or *pari passu* with the Bonds (other than any prepayment or repayment of Acquisition Facilities or Construction Facilities);
 - (vi) grant any loans except in the ordinary course of business; and
 - (vii) make any other similar distribution or transfers of value to any Person.
- (b) Notwithstanding the above, the Issuer and any other Group Company may:
 - (i) pay the management fee invoiced in accordance with the Management Agreement; ~~and~~
 - (ii) pay to the Guarantor amounts required to cover tax liabilities comprised by the joint taxation scheme in accordance with applicable tax legislation; and
 - (iii) with respect to the Subsidiaries only, pay dividend on its shares for the

sole purpose of upstreaming Divestment Net Proceeds or make a Project Distribution to the Issuer in order for the Issuer to execute a mandatory partial redemption in accordance with Clause 9.5 or Clause 9.6 (as applicable).

13.3 Nature of Business

- (a) Subject to paragraph (b) below, ~~the~~ the Issuer shall procure that no substantial change is made to the general nature of the business carried on by the Group as of the First Issue Date if such substantial change would have a Material Adverse Effect.
- (b) Notwithstanding paragraph (a), the Issuer may discontinue the business of a Group Company listed in Clause 13.5(b) below, provided that it has divested its project before the business being so discontinued.

13.4 Financial Indebtedness

The Issuer shall not, and shall procure that none of its Subsidiaries will, incur any Financial Indebtedness, other than Permitted Debt.

13.5 Disposal of Assets

- (a) ~~No~~Subject to paragraph (b) below, no assets that are subject to Transaction Security may be disposed of, unless the funds received by the Issuer from such disposal are deposited on the Blocked Account, which may thereafter be released by the Agent in its reasonable~~sole~~ discretion to:
 - (i) finance:~~(i) interest payments under the Bonds and~~ Bonds;
 - (ii) partially redeem the Bonds pursuant to Clauses 9.5 and 9.6;
 - (iii) execute a Permitted Reinvestment; or
 - (iv) finance Permitted Acquisitions, provided that Security is granted over the top holding company of the acquired property holding company and (ii) payments according to e~~Clause 13.2(b)(ii).~~13.2(b)(ii).
- (b) Notwithstanding paragraph (a) above, subject to the project of the relevant Group Company being divested, the Issuer may dispose of the shares in or discontinue the following Group Companies, and, by written notice to the Agent (the content of which the Agent shall not be required to verify), request the release of the relevant Transaction Security held over such Group Company or project upon the date of completion of such divestment or dissolution:
 - (i) Rødovre Port Holding ApS, CVR. no. 37043060;
 - (ii) HKP 1A Holding ApS, CVR. no. 39348942;

(iii) [Kanalgaden 3 Holding 1 ApS, CVR. no. 39357615; and](#)

[The Issuer's notice to the Agent shall confirm that the conditions for the release of Transaction Security as specified above have or will be met at the proposed release date and the notice shall contain a request for release of such Transaction Security at a specified date. For the avoidance of doubt, the application of any Divestment Net Proceeds and any amounts standing to the credit of the Blocked Account shall be governed by Clauses 9.5 and 9.6, as applicable.](#)

(c) The shares in the Issuer may however not be disposed of.

13.6 Negative Pledge

The Issuer shall not, and shall procure that none of its Subsidiaries will, provide, prolong or renew any Security over any of its/their assets (present or future), other than any Permitted Security.

13.7 Loans Out

The Issuer shall procure that itself and the Group Companies do not extend any loans in any form to any other party than to a Group Company.

13.8 Mergers and demergers

The Issuer shall procure that none of its Subsidiaries will enter into a merger or demerger, unless such merger constitutes a Permitted Merger or a Permitted Demerger.

13.9 Dealings at arm's length terms

The Issuer shall, and shall procure that its Subsidiaries, conduct all dealings with any person (other than Group Companies) at arm's length terms.

13.10 Compliance with laws and authorisations

The Issuer shall, and shall make sure that its Subsidiaries will (i) comply with all laws and regulations applicable from time to time, and (ii) obtain, maintain, and comply with, the terms and conditions of any authorisation, approval, licence or other permit required for the business carried out by a Group Company, in each case, if failure to do so has or is reasonably likely to have a Material Adverse Effect.

13.11 Insurance

The Issuer shall, and shall procure that its Subsidiaries will, keep their properties insured to an extent which is customary for similar properties on the relevant geographical market with one or more reputable insurers.

13.12 Environmental

The Issuer shall, and shall ensure that its Subsidiaries will, comply with all environmental laws and obtain, maintain and ensure compliance with all requisite environmental permits, if failure to do so has or is reasonably likely to have a Material Adverse Effect.

13.13 Projects specific undertakings

- (a) From (and including) the First Issue Date to (but excluding) the Amendment Effective Date, ~~T~~the Issuer shall procure that all new development projects, including Permitted Investments within the Group for which the Guarantor is the ultimate parent, are carried out within the direct or indirect Subsidiaries of the Issuer.
- (b) From (and including) Amendment Effective Date, the Issuer shall procure that all new development projects, including Permitted Investments within the Group for which the Guarantor is the ultimate parent and Minority Projects, are carried out (directly or indirectly) by Gefion Group Holdco III A/S, CVR. no. 55660018.
- (c) The Issuer shall procure:
 - (i) that all Minority Projects are subject to a monthly management fee of up to DKK 200,000 to cover operating expenses of such Minority Projects, payable to a Group Company or the Guarantor; and
 - (ii) if a Minority Project is subject to management fees that exceeds the amount stated in paragraph (i) above (or is subject to any other fee payable from a Minority Project referred to under this paragraph to a Group Company or the Guarantor), that an amount equal to such excess or additional fee is (A) reinvested into equity in the relevant Minority Project or (B) paid to the Blocked Account and used for partial redemption of the Bonds, subject to the Minimum Redemption Amount being met.

13.14 Admission to trading and maintenance of listing

The Issuer shall use its best efforts to ensure that the Bonds remain admitted to trading on the Marketplace until the date falling not later than ten (10) Business Days prior to the Final Maturity Date (or such earlier date on which the Bonds are redeemed in full), provided that, in respect of any Subsequent Bonds, the Issuer shall use its best efforts to procure admission to trading of such Subsequent Bonds on the Marketplace. The Issuer shall comply with the Marketplace Rules for as long as any Bonds are admitted to trading on the Marketplace and shall promptly notify the Agent if the Bonds cease, or are at risk of ceasing, to be so admitted.

14. Events of Default and Acceleration of the Bonds

Each of the events or circumstances set out in this Clause 14 (other than Clause 14.10 (*Acceleration of the Bonds*)) is an Event of Default.

14.1 Non-Payment

The Issuer fails to pay an amount on the date it is due in accordance with the Finance Documents unless:

- (a) its failure to pay is caused by administrative or technical error; and
- (b) payment is made within five (5) Business Days of the due date.

14.2 Other Obligations

A party (other than a finance party) fails to comply with the Finance Documents, in any other way than as set out in Clause 14.1 (*Non-Payment*), provided that no Event of Default will occur if the failure to comply is capable of being remedied and is remedied within fifteen (15) Business Days of the earlier of (i) the Issuer or that party becoming aware of the failure to comply and (ii) the Agent requesting the Issuer in writing to remedy such failure.

14.3 Cross-acceleration

Any Financial Indebtedness of a Group Company is:

- (a) not paid when due as extended by any originally applicable grace period (if there is one) and is declared to be due and payable; or
- (b) declared to be due and payable prior to its specified maturity as a result of an event of default, which is not remedied within any applicable remedy period (however described),

provided that no Event of Default will occur under this Clause 14.3 if (i) the aggregate amount of Financial Indebtedness that has fallen due is less than DKK 20,000,000, (ii) the Financial Indebtedness is owed to a Group Company, or (iii) the management board of the Issuer issues a statement to the Agent stating that the cross acceleration is not considered to have a Material Adverse Effect, unless there at the same time is a cross acceleration (subject to the DKK 20,000,000 threshold) in another Group Company.

14.4 Insolvency

If any Group Company:

- (a) is unable or admits its inability to pay its debts as they fall due or is declared to be unable to pay its debts under applicable law;
- (b) suspend its payments generally;
- (c) by reason of actual or anticipated financial difficulties, commences negotiations with its creditors generally with a view to rescheduling its Financial Indebtedness (excluding such negotiations with the Bondholders); or
- (d) a moratorium is declared in respect of the Financial Indebtedness of any Group Company,

provided, however that the fact that one Group Company, other than the Issuer, is deemed to be insolvent shall not constitute an Event of Default under this Clause 14.4 if the management of the board of the Issuer issues a statement to the Agent stating that the insolvency or insolvency proceedings is not considered to have a Material Adverse Effect, unless another Group Company is deemed to be insolvent at the same time.

14.5 Insolvency Proceedings

Any corporate action, legal proceedings or other procedures are taken (other than (i) proceedings or petitions which are being disputed in good faith and are discharged, stayed or dismissed within 120 days of commencement or, if earlier, the date on which it is advertised and (ii), in relation to Subsidiaries of the Issuer not being subject to Transaction Security, solvent liquidations) in relation to:

- (a) the suspension of payments, winding-up, dissolution, administration or reorganisation (by way of voluntary agreement, scheme of arrangement or otherwise) of any Group Company;
- (b) the appointment of a liquidator, receiver, administrator, administrative receiver, compulsory manager or other similar officer in respect of any Group Company or any of its assets or any analogous procedure or step is taken in any jurisdiction,

provided, however that any such insolvency proceedings with respect to a Group Company, other than the Issuer, shall not constitute an Event of Default under this Clause 14.5 if the management of the board of the Issuer issues a statement to the Agent stating that the insolvency or insolvency proceedings is not considered to have a Material Adverse Effect, unless another Group Company is subject to insolvency proceedings at the same time.

14.6 Creditors' Process

Any expropriation, attachment, sequestration, distress or execution or any analogous process in any jurisdiction affects any asset or assets of any Group Company having an aggregate value of an amount equal to or exceeding DKK 20,000,000 and is not discharged within 60 days, provided, however, that any such creditors' process, with respect to any Group Company other than the Issuer, shall not constitute an Event of Default under this ~~paragraph~~[Clause](#) 14.6 if the management board of the Issuer issues a statement to the Agent stating that the creditor's process is not considered to have a Material Adverse Effect, unless there at the same time is a creditor's process (subject to the DKK 20,000,000 threshold) in another Group Company.

14.7 Mergers and demergers

A decision is made that the Issuer shall enter into a merger where it is not the surviving entity or that it shall enter into a demerger where it ceases to exist.

14.8 Impossibility or Illegality

It is or becomes impossible or unlawful for the Issuer or any Group Company to fulfil or perform any of the provisions of the Finance Documents or if the obligations of the Issuer or a Group Company under the Finance Documents are not, or cease to be, legal, valid, binding and enforceable.

14.9 Continuation of the Business

The Issuer or any other Group Company ceases to carry on its business if such discontinuation is likely to have a Material Adverse Effect.

14.10 Acceleration of the Bonds

- (a) If an Event of Default has occurred and is continuing, the Agent is entitled to, on behalf of the Bondholders (i) by notice to the Issuer, declare all, but not some only, of the Bonds due for payment together with any other amounts payable under the Finance Documents, immediately or at such later date as the Agent determines (but such date may not fall after the Final ~~Redemption~~Maturity Date), and (ii) exercise any or all of its rights, remedies, powers and discretions under the Finance Documents.
- (b) The Agent may not accelerate the Bonds in accordance with Clause 14.10(a) by reference to a specific Event of Default if it is no longer continuing or if it has been decided, on a Bondholders' Meeting or by way of a Written Procedure, to waive such Event of Default (temporarily or permanently).
- (c) The Agent shall notify the Bondholders of an Event of Default within five (5) Business Days of the date on which the Agent received actual knowledge of that an Event of Default has occurred and is continuing. The Agent shall, within twenty (20) Business Days of the date on which the Agent received actual knowledge of that an Event of Default has occurred and is continuing, decide if the Bonds shall be so accelerated. If the Agent decides not to accelerate the Bonds, the Agent shall promptly seek instructions from the Bondholders in accordance with Clause 16 (*Decisions by Bondholders*). The Agent shall always be entitled to take the time necessary to consider whether an occurred event constitutes an Event of Default.
- (d) If the Bondholders (in accordance with these Terms and Conditions) instruct the Agent to accelerate the Bonds, the Agent shall promptly declare the Bonds due and payable and take such actions as may, in the opinion of the Agent, be necessary or desirable to enforce the rights of the Bondholders under the Finance Documents, unless the relevant Event of Default is no longer continuing.
- (e) Without prejudice to agreed rights of remedy, if the right to accelerate the Bonds is based upon a decision of a court of law or a government authority, it is not necessary that the decision has become enforceable under law or that the period of appeal has expired in order for cause of acceleration to be deemed to exist.

- (f) In the event of an acceleration of the Bonds in accordance with this Clause 14.10, the Issuer shall redeem all Bonds at an amount per Bond equal to ~~the~~ (i) 100 per cent. of the Nominal Amount, plus (ii) the applicable Redemption Premium, (ii) the Deferred Interest and (iv) Accrued But Unpaid Interest.

15. Distribution of Proceeds

- (a) All payments by the Issuer relating to the Bonds and the Finance Documents following an acceleration of the Bonds in accordance with Clause 14 (*Events of Default and Acceleration of the Bonds*) and any proceeds received from an enforcement of the Transaction Security shall (in the case of the Guarantee to the extent proceeds from the Guarantee can be applied towards satisfaction of the below) be made and/or distributed in the following order of priority:
- (i) *first*, in or towards payment *pro rata* of (i) all unpaid fees, costs, expenses and indemnities payable by the Issuer to the Agent in accordance with the Agency Agreement (other than any indemnity given for liability against the Bondholders), (ii) other costs, expenses and indemnities relating to the acceleration of the Bonds, the enforcement of the Transaction Security or the protection of the Bondholders' rights as may have been incurred by the Agent or the Security Agent, (iii) any costs incurred by the Agent or the Security Agent for external experts that have not been reimbursed by the Issuer in accordance with Clause 20.2(g), and (iv) any costs and expenses incurred by the Agent in relation to a Bondholders' Meeting or a Written Procedure that have not been reimbursed by the Issuer in accordance with Clause 16(m);
 - (ii) *secondly*, in or towards payment *pro rata* of ~~a~~Accrued ~~b~~But ~~u~~Unpaid Interest under the Bonds (Interest due on an earlier Interest Payment Date to be paid before any Interest due on a later Interest Payment Date);
 - (iii) *thirdly*, in or towards payment *pro rata* of any unpaid principal under the Bonds; and
 - (iv) *fourthly*, in or towards payment *pro rata* of any other costs or outstanding amounts unpaid under the Finance Documents.

Any excess funds after the application of proceeds in accordance with paragraphs (i) to (iv) above shall be paid to the Issuer.

- (b) Funds that the Agent receives (directly or indirectly) in connection with the acceleration of the Bonds or the enforcement of the Transaction Security constitute escrow funds (Sw. *redovisningsmedel*) and must be held on a separate interest-bearing account on behalf of the Bondholders and the other interested parties. The Agent shall arrange for payments of such funds in accordance with this Clause 15 as soon as reasonably practicable.
- (c) If the Issuer or the Agent shall make any payment under this Clause 15, the Issuer or the Agent, as applicable, shall notify the Bondholders of any such

payment at least fifteen (15) Business Days before the payment is made. Such notice shall specify the Record Date, the payment date and the amount to be paid. Notwithstanding the foregoing, for any Interest due but unpaid the Record Date specified in Clause 7(a) shall apply.

16. Decisions by Bondholders

- (a) A request by the Agent for a decision by the Bondholders on a matter relating to the Finance Documents shall (at the option of the Agent) be dealt with at a Bondholders' Meeting or by way of a Written Procedure.
- (b) Any request from the Issuer or a Bondholder (or Bondholders) representing at least ten (10) per cent. of the Adjusted Nominal Amount (such request may only be validly made by a Person who is a Bondholder on the Business Day immediately following the day on which the request is received by the Agent and shall, if made by several Bondholders, be made by them jointly) for a decision by the Bondholders on a matter relating to the Finance Documents shall be directed to the Agent and dealt with at a Bondholders' Meeting or by way of a Written Procedure, as determined by the Agent. The Person requesting the decision may suggest the form for decision making, but if it is in the Agent's opinion more appropriate that a matter is dealt with at a Bondholders' Meeting than by way of a Written Procedure, it shall be dealt with at a Bondholders' Meeting.
- (c) The Agent may refrain from convening a Bondholders' Meeting or instigating a Written Procedure if (i) the suggested decision must be approved by any Person in addition to the Bondholders and such Person has informed the Agent that an approval will not be given, or (ii) the suggested decision is not in accordance with applicable laws.
- (d) Only a Person who is, or who has been provided with a power of attorney or other authorisation pursuant to Clause 6 (*Right to Act on Behalf of a Bondholder*) from a Person who is, registered as a Bondholder:
 - (i) on the Record Date prior to the date of the Bondholders' Meeting, in respect of a Bondholders' Meeting, or
 - (ii) on the Business Day specified in the communication pursuant to Clause 18(c), in respect of a Written Procedure,

may exercise voting rights as a Bondholder at such Bondholders' Meeting or in such Written Procedure, provided that the relevant Bonds are included in the definition of Adjusted Nominal Amount.

- (e) The following matters shall require the consent of Bondholders representing at least sixty-six and two thirds ($66 \frac{2}{3}$) per cent. of the Adjusted Nominal Amount for which Bondholders are voting at a Bondholders' Meeting or for which Bondholders reply in a Written Procedure in accordance with the instructions given pursuant to Clause 18(c):

- (i) the issue of any Subsequent Bonds, if the total nominal amount of the Bonds exceeds, or if such issue would cause the total nominal amount of the Bonds to at any time exceed, DKK 500,000,000 (or the equivalent in SEK or EUR) (for the avoidance of doubt, for which consent shall be required at each occasion such Subsequent Bonds are issued);
 - (ii) a change to the terms of any of Clause 2(a), and Clauses 2(f) to 2(h);
 - (iii) a reduction of the premium payable upon the redemption or repurchase of any Bond pursuant to Clause 9 (*Redemption and Repurchase of the Bonds*);
 - (iv) a change to the Interest Rate or the Nominal Amount;
 - (v) waive a breach of or amend an undertaking set out in Clause 13 (*General Undertakings*);
 - (vi) a change to the terms for the distribution of proceeds set out in Clause 15 (*Distribution of Proceeds*);
 - (vii) a change to the terms dealing with the requirements for Bondholders' consent set out in this Clause 16;
 - (viii) a change of issuer, an extension of the tenor (other than pursuant to the Extension Option) of the Bonds or any delay of the due date for payment of any principal or interest on the Bonds;
 - (ix) a release of the Transaction Security, except in accordance with the terms of the Security Documents or these Terms and Conditions;
 - (x) a mandatory exchange of the Bonds for other securities; and
 - (xi) early redemption of the Bonds, other than upon an acceleration of the Bonds pursuant to Clause 14 (*Events of Default and Acceleration of the Bonds*) or as otherwise permitted or required by these Terms and Conditions.
- (f) Any matter not covered by Clause 16(e) shall require the consent of Bondholders representing more than 50 per cent. of the Adjusted Nominal Amount for which Bondholders are voting at a Bondholders' Meeting or for which Bondholders reply in a Written Procedure in accordance with the instructions given pursuant to Clause 18(c). This includes, but is not limited to, any amendment to, or waiver of, the terms of any Finance Document that does not require a higher majority (other than an amendment permitted pursuant to Clause 19(a)(i) or 19(a)(ii)), an acceleration of the Bonds or the enforcement of any Transaction Security.
- (g) Quorum at a Bondholders' Meeting or in respect of a Written Procedure only exists if a Bondholder (or Bondholders) representing at least fifty (50) per cent. of the Adjusted Nominal Amount in case of a matter pursuant to Clause 16(e), and otherwise twenty (20) per cent. of the Adjusted Nominal Amount:

- (i) if at a Bondholders' Meeting, attend the meeting in person or by telephone conference (or appear through duly authorised representatives); or
- (ii) if in respect of a Written Procedure, reply to the request.

If a quorum exists for some, but not all, of the matters to be dealt with at a Bondholders' Meeting or by a Written Procedure, decisions may be taken in the matters for which a quorum exists.

- (h) If a quorum does not exist at a Bondholders' Meeting or in respect of a Written Procedure, the Agent or the Issuer shall convene a second Bondholders' Meeting (in accordance with Clause 17(a)) or initiate a second Written Procedure (in accordance with Clause 18(a)), as the case may be, provided that the relevant proposal has not been withdrawn by the Person(s) who initiated the procedure for Bondholders' consent. The quorum requirement in Clause 16(g) shall not apply to such second Bondholders' Meeting or Written Procedure.
- (i) Any decision which extends or increases the obligations of the Issuer or the Agent, or limits, reduces or extinguishes the rights or benefits of the Issuer or the Agent, under the Finance Documents shall be subject to the Issuer's or the Agent's consent, as appropriate.
- (j) A Bondholder holding more than one Bond need not use all its votes or cast all the votes to which it is entitled in the same way and may in its discretion use or cast some of its votes only.
- (k) The Issuer may not, directly or indirectly, pay or cause to be paid any consideration to or for the benefit of any Bondholder for or as inducement to any consent under these Terms and Conditions, unless such consideration is offered *pro rata* to all Bondholders that consent at the relevant Bondholders' Meeting or in a Written Procedure within the time period stipulated for the consideration to be payable or the time period for replies in the Written Procedure, as the case may be.
- (l) A matter decided at a duly convened and held Bondholders' Meeting or by way of Written Procedure is binding on all Bondholders, irrespective of them being present or represented at the Bondholders' Meeting or responding in the Written Procedure. The Bondholders that have not adopted or voted for a decision shall not be liable for any damages that this may cause other Bondholders.
- (m) All costs and expenses incurred by the Issuer or the Agent for the purpose of convening a Bondholders' Meeting or for the purpose of carrying out a Written Procedure, including reasonable fees to the Agent, shall be paid by the Issuer.
- (n) If a decision shall be taken by the Bondholders on a matter relating to the Finance Documents, the Issuer shall promptly at the request of the Agent provide the Agent with a certificate specifying the number of Bonds owned by

Group Companies or (to the knowledge of the Issuer) Affiliates, irrespective of whether such Person is directly registered as owner of such Bonds. The Agent shall not be responsible for the accuracy of such certificate or otherwise be responsible to determine whether a Bond is owned by a Group Company or an Affiliate.

- (o) Information about decisions taken at a Bondholders' Meeting or by way of a Written Procedure shall promptly be sent by notice to the Bondholders and published on the websites of the Issuer and the Agent, provided that a failure to do so shall not invalidate any decision made or voting result achieved. The minutes from the relevant Bondholders' Meeting or Written Procedure shall at the request of a Bondholder be sent to it by the Issuer or the Agent, as applicable.

17. Bondholders' Meeting

- (a) The Agent shall convene a Bondholders' Meeting by sending a notice thereof to each Bondholder no later than five (5) Business Days after receipt of a request from the Issuer or the Bondholder(s) (or such later date as may be necessary for technical or administrative reasons).
- (b) Should the Issuer want to replace the Agent, it may convene a Bondholders' Meeting in accordance with Clause 17(a) with a copy to the Agent. After a request from the Bondholders pursuant to Clause 20.4(c), the Issuer shall no later than five (5) Business Days after receipt of such request (or such later date as may be necessary for technical or administrative reasons) convene a Bondholders' Meeting in accordance with Clause 17(a).
- (c) The notice pursuant to Clause 17(a) shall include (i) time for the meeting, (ii) place for the meeting, (iii) agenda for the meeting (including each request for a decision by the Bondholders) and (iv) a form of power of attorney. Only matters that have been included in the notice may be resolved upon at the Bondholders' Meeting. Should prior notification by the Bondholders be required in order to attend the Bondholders' Meeting, such requirement shall be included in the notice.
- (d) The Bondholders' Meeting shall be held no earlier than fifteen (15) Business Days and no later than thirty (30) Business Days from the notice.
- (e) Without amending or varying these Terms and Conditions, the Agent may prescribe such further regulations regarding the convening and holding of a Bondholders' Meeting as the Agent may deem appropriate. Such regulations may include a possibility for Bondholders to vote without attending the meeting in person.

18. Written Procedure

- (a) The Agent shall instigate a Written Procedure (which may be conducted electronically) no later than five (5) Business Days after receipt of a request from the Issuer or the Bondholder(s) (or such later date as may be necessary for

technical or administrative reasons) by sending a communication to each such Person who is registered as a Bondholder on the Business Day prior to the date on which the communication is sent.

- (b) Should the Issuer want to replace the Agent, it may send a communication in accordance with Clause 18(a) to each Bondholder with a copy to the Agent.
- (c) A communication pursuant to Clause 18(a) shall include (i) each request for a decision by the Bondholders, (ii) a description of the reasons for each request, (iii) a specification of the Business Day on which a Person must be registered as a Bondholder in order to be entitled to exercise voting rights, (iv) instructions and directions on where to receive a form for replying to the request (such form to include an option to vote yes or no for each request) as well as a form of power of attorney, and (v) the stipulated time period within which the Bondholder must reply to the request (such time period to last at least fifteen (15) Business Days from the communication pursuant to Clause 18(a)). If the voting shall be made electronically, instructions for such voting shall be included in the communication.
- (d) When the requisite majority consents of the total Adjusted Nominal Amount pursuant to Clauses 16(e) and 16(f) have been received in a Written Procedure, the relevant decision shall be deemed to be adopted pursuant to Clause 16(e) or 16(f), as the case may be, even if the time period for replies in the Written Procedure has not yet expired.

19. Amendments and Waivers

- (a) The Issuer and the Agent and/or the Security Agent (as applicable) (in each case acting on behalf of the Bondholders) may (without obtaining the consent of the Bondholders) agree to amend the Finance Documents or waive any provision in a Finance Document, provided that:
 - (i) such amendment or waiver is not detrimental to the interest of the Bondholders, or is made solely for the purpose of rectifying obvious errors and mistakes;
 - (ii) such amendment or waiver is required by applicable law, a court ruling or a decision by a relevant authority; or
 - (iii) such amendment or waiver has been duly approved by the Bondholders in accordance with Clause 16 (*Decisions by Bondholders*).
- (b) The consent of the Bondholders is not necessary to approve the particular form of any amendment to the Finance Documents. If required, it is sufficient if such consent approves the substance of the amendment or waiver.
- (c) The Agent shall promptly notify the Bondholders of any amendments or waivers made in accordance with Clause 19(a), setting out the date from which the amendment or waiver will be effective, and ensure that any amendments to the Finance Documents are published in the manner stipulated in Clause 11.3

(*Publication of Finance Documents*). The Issuer shall ensure that any amendments to the Finance Documents are duly registered with the CSD and each other relevant organisation or authority, to the extent such registration is possible with the rules of the relevant CSD.

- (d) An amendment to the Finance Documents shall take effect on the date determined by the Bondholders' Meeting, in the Written Procedure or by the Agent, as the case may be.

20. Appointment and Replacement of the Agent and the Security Agent

20.1 Appointment of the Agent and the Security Agent

- (a) The Issuer appoints the Agent to act as representative (in Danish: *fuldmægtig og repræsentant*) on behalf of and for the benefit of the Bondholders pursuant to Chapter 4 of the Danish Capital Markets Act. The Agent accepts such appointment. Each Secured Party hereby appoints the Security Agent to act and hold the Transaction Security as agent and representative (in Danish: *fuldmægtig og repræsentant*) for Secured Parties in accordance with Chapter 4 of the Danish Capital Markets Act.
- (b) By subscribing for Bonds, each initial Bondholder appoints the Agent and the Security Agent to act as its agent and security agent (as applicable) in all matters relating to the Bonds and the Finance Documents, and authorises each of the Agent and the Security Agent to act on its behalf (without first having to obtain its consent, unless such consent is specifically required by these Terms and Conditions) in any legal or arbitration proceedings relating to the Bonds held by such Bondholder including any legal or arbitration proceeding relating to the perfection, preservation, protection or enforcement of the Transaction Security.
- (c) By acquiring Bonds, each subsequent Bondholder confirms the appointment and authorisation for the Agent and the Security Agent to act on its behalf, as set forth in ~~Clause 20.1(a) and (b)~~ [paragraphs \(a\) and \(b\) above](#).
- (d) Each Bondholder shall immediately upon request provide the Agent and the Security Agent with any such documents, including a written power of attorney (in form and substance satisfactory to the Agent or the Security Agent, as applicable), that the Agent or the Security Agent (as applicable) deems necessary for the purpose of exercising its rights and/or carrying out its duties under the Finance Documents. Neither the Agent nor the Security Agent is under any obligation to represent a Bondholder which does not comply with such request.
- (e) The Issuer shall promptly upon request provide the Agent and the Security Agent with any documents and other assistance (in form and substance satisfactory to the Agent or the Security Agent, as applicable), that the Agent or the Security Agent (as applicable) deems necessary for the purpose of exercising its rights and/or carrying out its duties under the Finance Documents.

- (f) Each of the Agent and the Security Agent is entitled to fees for its respective work and to be indemnified for costs, losses and liabilities on the terms set out in the Finance Documents and the Agent's and the Security Agent's respective obligations as Agent and Security Agent (as applicable) under the Finance Documents are conditioned upon the due payment of such fees and indemnifications.
- (g) Each of the Agent and the Security Agent may act as agent or trustee for several issues of securities issued by or relating to the Issuer and other Group Companies notwithstanding potential conflicts of interest.

20.2 Duties of the Agent and the Security Agent

- (a) Each of the Agent and the Security Agent shall represent the Bondholders subject to and in accordance with the Finance Documents, including, *inter alia*, holding the Transaction Security pursuant to the Security Documents on behalf of the Bondholders and, where relevant, enforcing the Transaction Security on behalf of the Bondholders. Neither the Agent nor the Security Agent is responsible for the content, valid execution, legal validity or enforceability of the Finance Documents or the perfection of the Transaction Security.
- (b) When acting in accordance with the Finance Documents, each of the Agent and the Security Agent is always acting with binding effect on behalf of the Bondholders. Each of the Agent and the Security Agent shall carry out its duties under the Finance Documents in a reasonable, proficient and professional manner, with reasonable care and skill.
- (c) Each of the Agent and the Security Agent's duties under the Finance Documents are solely mechanical and administrative in nature and the Agent and the Security Agent only acts in accordance with the Finance Documents and upon instructions from the Bondholders, unless otherwise set out in the Finance Documents. In particular, neither the Agent nor the Security Agent is acting as an advisor (whether legal, financial or otherwise) to the Bondholders or any other Person.
- (d) Neither the Agent nor the Security Agent is obligated to assess or monitor the financial condition of the Issuer or compliance by the Issuer with the terms of the Finance Documents except to the extent expressly set out in the Finance Documents, or to take any steps to ascertain whether any Event of Default (or any event that may lead to an Event of Default) has occurred. Until it has actual knowledge to the contrary, each of the Agent and the Security Agent is entitled to assume that no Event of Default (or any event that may lead to an Event of Default) has occurred.
- (e) Each of the Agent and the Security Agent is entitled to delegate its duties to other professional parties, but each of them shall remain liable for the actions of such parties under the Finance Documents.
- (f) Each of the Agent and the Security Agent shall treat all Bondholders equally and, when acting pursuant to the Finance Documents, act with regard only to the

interests of the Bondholders and shall not be required to have regard to the interests or to act upon or comply with any direction or request of any other Person, other than as explicitly stated in the Finance Documents.

- (g) Each of the Agent and the Security Agent is entitled to engage external experts when carrying out its duties under the Finance Documents. The Issuer shall on demand by the Agent and/or the Security Agent pay all costs for external experts engaged after the occurrence of an Event of Default, or for the purpose of investigating or considering (i) an event which the Agent reasonably believes is or may lead to an Event of Default, (ii) a matter relating to the Issuer or the Transaction Security which the Agent and/or the Security Agent reasonably believes may be detrimental to the interests of the Bondholders under the Finance Documents or (iii) as otherwise agreed between the Agent and/or the Security Agent and the Issuer. Any compensation for damages or other recoveries received by the Agent and/or the Security Agent from external experts engaged by it for the purpose of carrying out its duties under the Finance Documents shall be distributed in accordance with Clause 15 (*Distribution of Proceeds*).
- (h) Notwithstanding any other provision of the Finance Documents to the contrary, neither the Agent nor the Security Agent is obliged to do or omit to do anything if it would or might in its reasonable opinion constitute a breach of any law or regulation.
- (i) If in the Agent's or Security Agent's (as applicable) reasonable opinion the cost, loss or liability which it may incur (including its respective reasonable fees) in complying with instructions of the Bondholders, or taking any action at its own initiative, will not be covered by the Issuer, or the Bondholders (as applicable), the Agent or the Security Agent (as applicable) may refrain from acting in accordance with such instructions, or taking such action, until it has received such funding or indemnities (or adequate Security has been provided therefore) as it may reasonably require.
- (j) Unless it has actual knowledge to the contrary, each of the Agent and the Security Agent may assume that all information provided by or on behalf of the Issuer (including by its advisors) is correct, true and complete in all aspects.
- (k) Each of the Agent and the Security Agent shall give a notice to the Bondholders (i) before it ceases to perform its obligations under the Finance Documents by reason of the non-payment by the Issuer of any fee or indemnity due to the Agent or the Security Agent under the Finance Documents or (ii) if it refrains from acting for any reason described in Clause 20.2(i).

20.3 Limited liability for the Agent and the Security Agent

- (a) Neither the Agent nor the Security Agent will be liable to the Bondholders for damage or loss caused by any action taken or omitted by it under or in connection with any Finance Document, unless directly caused by its gross negligence or wilful misconduct. Neither the Agent nor the Security Agent shall be responsible for indirect loss.

- (b) Neither the Agent nor the Security Agent shall be considered to have acted negligently if it has acted in accordance with advice addressed to it from or opinions of reputable external experts or if it has acted with reasonable care in a situation when it considers that it is detrimental to the interests of the Bondholders to delay the action in order to first obtain instructions from the Bondholders.
- (c) Neither the Agent nor the Security Agent shall be liable for any delay (or any related consequences) in crediting an account with an amount required pursuant to the Finance Documents to be paid by it to the Bondholders, provided that it has taken all necessary steps as soon as reasonably practicable to comply with the regulations or operating procedures of any recognised clearing or settlement system used by it for that purpose.
- (d) Neither the Agent nor the Security Agent shall have any liability to the Bondholders for damage caused by it acting in accordance with instructions of the Bondholders given in accordance with the Finance Documents.
- (e) Any liability towards the Issuer which is incurred by the Agent or the Security Agent in acting under, or in relation to, the Finance Documents shall not be subject to set-off against the obligations of the Issuer to the Bondholders under the Finance Documents.
- (f) The Agent is not liable for information provided to the Bondholders by or on behalf of the Issuer or any other Person.

20.4 Replacement of the Agent and the Security Agent

- (a) Subject to Clause 20.4(f), each of the Agent and the Security Agent may resign by giving notice to the Issuer and the Bondholders, in which case the Bondholders shall appoint a successor Agent and/or the Security Agent at a Bondholders' Meeting convened by the retiring Agent or by way of Written Procedure initiated by the retiring Agent.
- (b) Subject to Clause 20.4(f), if the Agent and/or the Security Agent is Insolvent, the Agent and/or the Security Agent (as applicable) shall be deemed to resign as Agent and/or the Security Agent (as applicable) and the Issuer shall within ten (10) Business Days appoint a successor Agent and/or a successor Security Agent (as applicable) which shall be an independent financial institution or other reputable company which regularly acts as agent under debt issuances.
- (c) A Bondholder (or Bondholders) representing at least ten (10) per cent. of the Adjusted Nominal Amount may, by notice to the Issuer (such notice may only be validly given by a Person who is a Bondholder on the Business Day immediately following the day on which the notice is received by the Issuer and shall, if given by several Bondholders, be given by them jointly), require that a Bondholders' Meeting is held for the purpose of dismissing the Agent and/or the Security Agent and appointing a new Agent and/or the new Security Agent (as applicable). The Issuer may, at a Bondholders' Meeting convened by it or by way of Written Procedure initiated by it, propose to the Bondholders that the Agent

and/or the Security Agent be dismissed and a new Agent and/or a new Security Agent (as applicable) be appointed.

- (d) If the Bondholders have not appointed a successor Agent and/or successor Security Agent within ninety (90) days after (i) the earlier of the notice of resignation was given or the resignation otherwise took place or (ii) the Agent and/or the Security Agent was dismissed through a decision by the Bondholders, the Issuer shall appoint a successor Agent and/or successor Security Agent (as applicable) which shall be an independent financial institution or other reputable company which regularly acts as agent under debt issuances.
- (e) The retiring Agent and/or the retiring Security Agent (as applicable) shall, at its own cost, make available to the successor Agent and/or the successor Security Agent (as applicable) such documents and records and provide such assistance as the successor Agent and/or successor Security Agent may reasonably request for the purposes of performing its functions as Agent and/or the Security Agent (as applicable) under the Finance Documents.
- (f) The Agent's and the Security Agent's resignation or dismissal shall only take effect upon the appointment of a successor Agent and/or the successor Security Agent (as applicable) and acceptance by such successor Agent and/or the successor Security Agent (as applicable) of such appointment and the execution of all necessary documentation to effectively substitute the retiring Agent and/or the retiring Security Agent (as applicable).
- (g) Upon the appointment of a successor, the retiring Agent and/or the retiring Security Agent shall be discharged from any further obligation in respect of the Finance Documents but shall remain entitled to the benefit of the Finance Documents and remain liable under the Finance Documents in respect of any action which it took or failed to take whilst acting as Agent and/or the Security Agent (as applicable). Its successor, the Issuer and each of the Bondholders shall have the same rights and obligations amongst themselves under the Finance Documents as they would have had if such successor had been the original Agent and/or the Security Agent.
- (h) In the event that there is a change of the Agent and/or the Security Agent in accordance with this Clause 20.4, the Issuer shall execute such documents and take such actions as the new Agent and/or the new Security Agent may reasonably require for the purpose of vesting in such new Agent and/or the new Security Agent (as applicable) the rights, powers and obligation of the Agent and/or the Security Agent and releasing the retiring Agent and/or the retiring Security Agent (as applicable) from its respective further obligations under the Finance Documents. Unless the Issuer and the new Agent and/or the new Security Agent agrees otherwise, the new Agent and/or the new Security Agent shall be entitled to the same fees and the same indemnities as the retiring Agent and/or the retiring Security Agent (as applicable).

21. Appointment and Replacement of the CSD

- (a) The Issuer has appointed the CSD to manage certain tasks under these Terms and Conditions and in accordance with the CSD regulations and the other regulations applicable to the Bonds.
- (b) The CSD may retire from its assignment or be dismissed by the Issuer provided that the Issuer has effectively appointed a replacement CSD that accedes as CSD at the same time as the old CSD retires or is dismissed and provided also that the replacement does not have a negative effect on any Bondholder. The replacing CSD must be authorized to professionally conduct clearing operations pursuant to the Swedish Securities Markets Act (*lag (2007:528) om värdepappersmarknaden*) or Regulation (EU) no. 909/2014 and be authorized as a central securities depository in accordance with the Financial Instruments Accounts Act.

22. Appointment and Replacement of the CSD Agent

- (a) The Issuer appoints the CSD Agent to manage certain specified tasks under these Terms and Conditions and in accordance with the legislation, rules and regulations applicable to and/or issued by the CSD and relating to the Bonds.
- (b) The CSD Agent may retire from its assignment or be dismissed by the Issuer, provided that the Issuer has approved that a commercial bank or securities institution approved by the CSD accedes as new CSD Agent at the same time as the old CSD Agent retires or is dismissed. If the CSD Agent is Insolvent, the Issuer shall immediately appoint a new CSD Agent, which shall replace the old CSD Agent as CSD Agent in accordance with these Terms and Conditions.

23. No Direct Actions by Bondholders

- (a) A Bondholder may not take any steps whatsoever against the Issuer or with respect to the Transaction Security to enforce or recover any amount due or owing to it pursuant to the Finance Documents, or to initiate, support or procure the winding-up, dissolution, liquidation, company reorganisation (Sw. *företagsrekonstruktion*) or bankruptcy (Sw. *konkurs*) (or its equivalent in any other jurisdiction) of the Issuer in relation to any of the liabilities of the Issuer under the Finance Documents.
- (b) Clause 23(a) shall not apply if the Agent has been instructed by the Bondholders in accordance with the Finance Documents to take certain actions but fails for any reason to take, or is unable to take (for any reason other than a failure by a Bondholder to provide documents in accordance with Clause 20.1(a)), such actions within a reasonable period of time and such failure or inability is continuing. However, if the failure to take certain actions is caused by the non-payment by the Issuer of any fee or indemnity due to the Agent under the Finance Documents or by any reason described in Clause 20.2(i), such failure must continue for at least forty (40) Business Days after notice pursuant to Clause 20.2(k) before a Bondholder may take any action referred to in Clause 23(a).

- (c) The provisions of Clause 23(a) shall not in any way limit an individual Bondholder's right to claim and enforce payments which are due to it under Clause 9.4 (*Voluntary partial redemption*)
- ~~(d) *The Issuer may redeem the Bonds on one occasion before 11 November 2025 and on one occasion after such date (assuming that the Extension Option has been exercised) (without carry back or carry forward) in a minimum aggregate amount not less than ten (10) per cent. of the total Initial Nominal Amount. The repayment must occur on an Interest Payment Date. The repayment per Bond shall be equal the repaid percentage of the Nominal Amount (rounded down to the nearest SEK and EUR 1.00 (as applicable)) together with any accrued but unpaid interest on the redeemed amounts.*~~
- ~~(e) *Partial redemption in accordance with this Clause 9.4 shall be made by the Issuer giving not less than fifteen (15) Business Days' notice to the Bondholders and the Agent. Any such notice is irrevocable and, upon expiry of such notice, the Issuer is bound to redeem the Bonds in part on the immediately following Interest Payment Date at the applicable amounts. The applicable amount shall be an even amount in SEK and EUR (as applicable) and paid to the Person who is registered as a Bondholder on the Record Date prior to the relevant Redemption Date.*~~
- (f) *Mandatory Repurchase due to a Change of Control Event (Put Option)* *Voluntary partial redemption* or other payments which are due by the Issuer to some but not all Bondholders.

24. Prescription

- (a) The right to receive repayment of the principal of the Bonds shall be prescribed and become void ten (10) years from the Redemption Date. The right to receive payment of interest (excluding any capitalised interest) shall be prescribed and become void three (3) years from the relevant due date for payment. The Issuer is entitled to any funds set aside for payments in respect of which the Bondholders' right to receive payment has been prescribed and has become void.
- (b) If a limitation period is duly interrupted in accordance with the Swedish Act on Limitations (Sw. *preskriptionslag (1981:130)*), a new limitation period of ten (10) years with respect to the right to receive repayment of the principal of the Bonds, and of three (3) years with respect to receive payment of interest (excluding capitalised interest) will commence, in both cases calculated from the date of interruption of the limitation period, as such date is determined pursuant to the provisions of the Swedish Act on Limitations.

25. Notices and Press Releases

25.1 Notices

- (a) Any notice or other communication to be made under or in connection with the Finance Documents:

- (i) if to the Agent, shall be given at the address registered with the Swedish Companies Registration Office (Sw. *Bolagsverket*) on the Business Day prior to dispatch or, if sent by email by the Issuer, to the email address notified by the Agent from time to time;
 - (ii) if to the Issuer, shall be given at the address registered with the Danish Business Authority (Dk. *Ehrvervsstyrelsen*) on the Business Day prior to dispatch or if sent by email by the Agent, to the email address notified by the Issuer to the Agent from time to time; and
 - (iii) if to the Bondholders, shall be given at their addresses as registered with the CSD, on the Business Day prior to dispatch, and by either courier delivery (if practically possible) or letter for all Bondholders. A notice to the Bondholders shall also be available to the Bondholders on the websites of the Issuer and the Agent.
- (b) Any notice or other communication made by one Person to another under or in connection with the Finance Documents shall be sent by way of courier, personal delivery or letter, or if between the Issuer and the Agent, by email, and will only be effective:
 - (i) in case of courier or personal delivery, when it has been left at the address specified in Clause 25.1(a);
 - (ii) in case of letter, three (3) Business Days after being deposited postage prepaid in an envelope addressed to the address specified in Clause 25.1(a); or
 - (iii) in case of email, on the day of dispatch (unless a delivery failure message was received by the sender), save that any notice or other communication sent by email that is sent after 5.00 pm in the place of receipt shall be deemed only to become effective on the following day.
- (c) Failure to send a notice or other communication to a Bondholder or any defect in it shall not affect its sufficiency with respect to other Bondholders.

25.2 Press releases

- (a) Any notice that the Issuer or the Agent shall send to the Bondholders pursuant to Clauses 9.3 (*Voluntary Total Redemption (Call Option)*), 11.1(c), 14.10(c), 16(o), 17(a), 18(a) and 19(c) shall also be published by way of press release by the Issuer or the Agent, as applicable.
- (b) In addition to Clause 25.2(a), if any information relating to the Bonds or the Issuer contained in a notice the Agent may send to the Bondholders under these Terms and Conditions has not already been made public by way of a press release, the Agent shall before it sends such information to the Bondholders give the Issuer the opportunity to issue a press release containing such information. If the Issuer does not promptly issue a press release and the Agent considers it necessary to issue a press release containing such information before it can

lawfully send a notice containing such information to the Bondholders, the Agent shall be entitled to issue such press release.

26. Force Majeure and Limitation of Liability

- (a) None of the Agent, the Security Agent or the CSD Agent shall be held responsible for any damage arising out of any legal enactment, or any measure taken by a public authority, or war, strike, lockout, boycott, epidemics, pandemics, blockade or any other similar circumstance (a "**Force Majeure Event**"). The reservation in respect of strikes, lockouts, boycotts, epidemics, pandemics, and blockades applies even if the Agent, the Security Agent or the CSD Agent itself takes such measures, or is subject to such measures.
- (b) The CSD Agent shall have no liability to the Bondholders if it has observed reasonable care. The CSD Agent shall never be responsible for indirect damage with exception of gross negligence and willful misconduct.
- (c) Should a Force Majeure Event arise which prevents the Agent, the Security Agent or the CSD Agent from taking any action required to comply with these Terms and Conditions, such action may be postponed until the obstacle has been removed.
- (d) The provisions in this Clause 26 apply unless they are inconsistent with the provisions of the Financial Instruments Accounts Act which provisions shall take precedence.

27. Governing Law and Jurisdiction

- (a) These Terms and Conditions, and any non-contractual obligations arising out of or in connection therewith, shall be governed by and construed in accordance with the laws of Swedish.
- (b) The Issuer submits to the non-exclusive jurisdiction of the CityDistrict Court of Stockholm (Sw. *Stockholms tingsrätt*).
- (c) Paragraphs ~~(a) and (b)~~(a) and (b) above shall not limit the right of the Agent or the Security Agent (or the Bondholders, as applicable) to take proceedings against the Issuer or any Group Company in any court which may otherwise exercise jurisdiction over the Issuer, any Group Company or any of its assets.
