March Statistics report from the Nasdaq Nordic and Baltic markets

The value of average daily share trading amounted to EUR 3.5 billion, compared to EUR 3.3 billion during the past 12-month period. The average number of trades per trading day was 723,634 compared to 760,730 during the past 12-month period. The average number of cleared derivatives contracts per trading day amounted 474,310 compared to 340,776 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic and Baltic markets amounted to EUR 1 787 billion, compared to EUR 1 924 billion in March 2022.

All figures below are in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK, Iceland in ISK and Baltic Exchanges in EUR) and average per trading day. Tallinn and Vilnius had 19 trading days and all other exchanges had 23 trading days.
